

Located on Main Street at the Plaza across the street from Mainplace Mall, The Habit is sure to satisfy your cravings. Upon entering the restaurant, Sergio and I were greeted by a long line. As we waited, we gazed at the menu that was simple containing only select hamburgers, house salads, sandwiches, chicken tenders, fries, and an assortment of beverages and desserts. The menu seemed plain but the food was nothing short of rich in flavor.

restaurant is a Santa Barbara beach shack with pale yellow walls that bring the customers back to the days of a warm sunnv beach shore. Wooden planks line the ceiling resembling a board walk. Beach art also lines the walls. Customers at The Habit, as well as the employees, were in casual attire. The Habit is a familyfriendly place, so don't be afraid to invite anybody. The two of us

placed our order with a friendly waitress that made sure we were pleased with our selection. After ordering, we stepped out into the patio area. Large red umbrellas adorn the simple

wooden picnic tables. We returned to the tables to indulge on our meal. Minutes after sitting at our table, our order was called up through a speaker. I ordered the Charburger (\$5.95) that included fries and a regular drink. Sergio ordered a Fresh Albacore Tuna sandwich (\$5.75) with a side of sweet potato fries (\$2.00) and a regular drink (\$1.65). The food was worth every cent with the burgers rivaling those of In-N-Out. Unique dishes like the sweet potato fries brought us away from the norm of plain salted fries. The burger was neither overwhelmingly large nor too small to leave one hungry. Paper wrapped

basket, the burger is well put together and does not resemble your typical fast food chain burger which may resemble a Jenga; a mess of condiments stacked on top of each other. The burger was delicious and made fresh to order. The tuna sandwich was a new take on the fish sandwich. While it did taste like fish, it wasn't the typical overpowering flavor of the fish that dominated our taste buds but rather it was the taste of the sauces and the fish that worked together to create the best tasting fish sandwich we've ever had the pleasure to eat. The sweet potato fries were just amazing as well. Alone they stand their ground but when enjoyed with any other of The Habit's dishes, they

make the meal something special and memorable. The sweetness of the fries was great for balancing the salty nature of the burgers and tuna. Throughout our dining experience a waiter would occasionally walk outside to check up on us. Every visit from the waiter was pleasant because he would ensure that we were comfortable by offering us a refill on our beverages, extra condiments, and he would clear our table of empty trays. After our visit

to The Habit we were fully satisfied with our meals and we already started planning our return to have another burger. All in all, we'd rate this burger joint as a "must go."

Verizon has announced that the giant of smartphones: the iPhone 4 is coming to its network. The cost for the device will be \$199.99 for the 16gb version, and \$299.99 for 32gb. 

Over recent years, the ongoing dispute about illegal immigration has shone light on the DREAM Act and its benefits. According to the National Immigration Law Center, the benefits of the DREAM Act are not just beneficial to those who are accepted within the limitations of the bill but to the rest of the country. One of the benefits would be a reduction in dropout rates. Giving students an incentive to go to school, especially minorities, would reduce the number of students who leave school. It creates fewer barriers for illegal

college. This leads to the second benefit of an advanced education at a university or college. By learning a profession, those once illegal immigrants will have the opportunity to go out into the consumer market and perhaps help stimulate the economy.

Hope for the DREAM Act

The opposition argues, though, that more people will want to come to the US to take advantage of the bill and this would snatch away the spots in college from students who are natural born citizens. They feel that the bill is like an amnesty and a reward for entering the United States illegally. Should the DREAM Act eventually pass, illegal immigrant students would have to first apply for the DREAM Act and be approved for Conditional Permanent Residency.

Afterwards, the person would have to be enrolled in college or university or enlist in any branch of the military. Within 6 years, the person must have completed at least 2 years at the place of their choice. Once 5 and a half years of the 6 years have passed, the person may be able to apply for Legal Permanent Residency and then for citizenship. Last year,

### Are School Fees Legit? School Fees = Broke



ACLU affiliates file a lawsuit against the state of California for illegitimate school fees.

On September 9th, 2010, American Civil Liberties Union affiliates in Southern California, Northern California, San Diego and Imperial Counties filed a lawsuit in the Los Angeles Superior Court against the state of California and former Governor Arnold Schwarzenegger for allowing school districts to charge fees for books and other required educational supplies. The obvious question prevails; does this violate the California Constitution that guaranteed children a free education since 1879? Article IX, Section I of the California Constitution states that, "A general diffusion of knowledge and intelligence being essential to the preservation of the rights and liberties of the people, the Legislature shall encourage by all suitable means the promotion of intellectual, scientific, moral, and agricultural improvement."

The lawsuit followed an investigation by the ACLU that uncovered approximately **40** school districts who forced students to purchase textbooks, workbooks, and assigned novels in order to enroll in their classes. In addition, these school districts also charged students to take Advanced Placement examinations. The suit disputes that this discriminating practice against lower-income children will result in an unfair system where only the wealthy will be able to afford an education that is constitutionally supposed to be free to all, regardless of their economic status.

"School districts know they cannot charge students for an education; this practice was struck down by the California Supreme Court in **1984**," said Ramona Ripston, Executive Director of the ACLU/SC. "The court said no to 'pay-to-play' then, and it should be no different now."

In one such incident, a student's Spanish teacher wrote the teenager's name on the board because of failure to pay for the assigned workbooks. The school required this student to pay approximately \$440 annually in course and uniform fees, thus mak-

ing it an extreme financial burden for the student's family.

However, on December 9th, the ACLU California affiliates announced a settlement with the State of California, which still requires court approval, that will establish a comprehensive monitoring and enforcement system to ensure that school districts do not unlawfully charge fees to students for educational activities. The settlement empowers students and parents to use the Williams Uniform Complaint Process in order to receive reimbursement for unlawful school fees. If auditors find that a district charged illegitimate fees, the district would be required to fully reimburse parents or suffer a financial penalty. Furthermore, parents would be able to challenge these illegal fees immediately within **30** working days.

"I am proud of the settlement we have reached, and assure all California parents and students that the State will do its part to make sure every school district knows it is illegal to charge students a fee for attending public schools," said former Governor Schwarzenegger.

In addition, the State agreed to send guidance regarding student fees to all county and district superintendents and charter school administrators reminding them that public education will be provided to all students, regardless of families' ability or willingness to pay fees. The State also agreed on pursuing legislation confirming that districts should not charge fees for educational activities, and spelling out the types of services that must be provided to all students free of any charge.

During these times of financial hardships, students, and predominantly parents, no longer have to worry of not being able to pay the required fees in order to participate or enroll in a certain course or activity. As residents of California, students have the right to freely participate in their desired courses with a guaranteed free education, regardless of their economic status.

In late **2010**, President Barack Obama signed into law the Healthy Hunger-Free Kids Act—H.R. **2053**— at Harriet Tubman Elementary School in Washington D.C.. The purpose of such a law is to provide children with healthier school lunches. With childhood obesity on the rise, and the omnipresence of type II diabetes, this new piece of legislation shines light on the health of future America.

Approximately 115,000 more children will have access to a free school lunch in America.

First Lady Michelle Obama played an active role in the lobbying of this act and rejoices at the notion that with new regulation of our school lunches and an emphasis on physical activity, the health of children should improve. She fought for this because "We can agree that in the wealthiest nation on earth, all children should have the basic nutrition they need to learn and grow," she said. With the implementation of this new act, the Obama administration hopes to provide more

lies beyond people's addictions, and rests in the cultural ties we have with these drugs.

The plant cannabis, commonly known as Marijuana, grows all over the world as a weed. Its earliest recorded uses were in ancient China and India, where it was traded to Arabs who shipped it to North Africa and Spain. Although Cannabis was also used as an intoxicant, it was also a prized source of fiber for ropes and Canvas in ships.

Napoleon Bonaparte introduced cannabis to Europe after one of his campaigns in North Africa, taking it as a spoil of war because, unlike alcohol, cannabis does not cause a hangover. Queen Victoria of England used cannabis for menstrual pains, and the drug was also used to treat insomnia, and tuberculosis pains, among other pains. Abdu Jamid II, when he traveled to the U.S. in **1876**, on the **100**th birthday of the Declaration of Independence, introduced Americans to smoking marijuana as a gift.

It wasn't until prohibition, however, that smoking cannabis became a popular intoxicant in Louisiana and other Southern States. Also attributed to the rise of the popularity of marijuana was the increase of Mexican immigrants during the roaring **20**'s. The Federal Bureau of Narcotics, under Harry J. meals to more students. An additional six cents will be spent on every child's meal by allocating \$4.5 billion to school lunch programs over a ten year period.

According to Godinez Fundamental High School's Food Supervisor, Vera Montejano, the school has adjusted its meal plans by ridding the campus of sugary, fizzy drinks and assures that every meal provided to the students is "approved by the federal government." To help students make healthier choices, potato chip options have been altered so that "Baked" versions are more abundant on campus, readily available, and every meal has been pre-measured to assure that they comply with FDA recommended portions. The school can expect to see the addition or removal of certain meal items from the lunch rack due to our new Director of Food Services, Jan Monfort. Her past position was in LAUSD as the Director of Food Services. With her presiding over the Food Service Department, we may see an increase in salad options such as more diverse fruit and vegetable choices. Godinez High School, be prepared for small but significant changes in your school meals.

The South got the law they wanted in the Marijuana Tax Act, which required people to pay a tax before buying, selling, or transferring Marijuana. The law was therefore overturned in the Supreme Court under Leary v. United States (1969), and decriminalized permanently under the Controlled Substance Act of 1970.

An example of this is the recently shot down Prop **19** of California, which called for legalization of the drug in the state of California. The supporters of the law argued that legalization will help cancer patients, boost the economy by the creation of cannabis-related jobs, and stop Mexican cartels by cutting one of their greatest exports. However, legalization seems unlikely, for many people have come to believe, as Anslinger wanted, that cannabis is a menace and has no place in our world.


#### 2. Blade Runner


