Dear Parent(s) and Guardian(s):

There are many ways to measure your child's learning. Your child's teacher uses report card grades, classroom work, teacher observations, and end-of-year statewide test results to get a complete picture of your child's learning. For the 2023 spring administration of the California Assessment of Student Performance and Progress (CAASPP) and the Summative English Language Proficiency Assessments for California (ELPAC), students will continue to take their assigned tests in-person. Our priority is to continue keeping our students and educators safe by following state, county, and local health and safety guidance and take all necessary precautions to ensure our schools remain among the safest places for children.

Below is a table outlining the 2022-2023 CAASPP and ELPAC assessments that your child could participate in, depending on their grade level or instructional program.

California Spanish Assessment (CSA) Optional	Students who speak Spanish as their primary language, as well as those who are learning Spanish as an additional language.	3-8 and High School	Reading/Language Arts in Spanish	Computer-Based (In-Person)	March - June
English Language Proficiency Assessments for California (Summative ELPAC)	All students who are identified as English learners unless their Individualized Education Program (IEP) indicates assessment with an Alternate Assessment.	K-12	Listening, Speaking, Reading and Writing	Computer-Based and (K-2 Writing Paper-pencil) (In-Person)	Feb May
Alternate English Language Proficiency Assessments for California (Alternate ELPAC)	English learners with disabilities characterized as moderate or severe, who are unable to take the Summative ELPAC even with supports or accommodations and whose Individualized Education Program (IEP) indicates an alternate assessment.	K-12	Listening, Speaking, Reading and Writing	Computer-Based (In-Person)	Feb May

You are an important part of your child's education. To help your child get ready for the test, please be sure that you talk about the test with your child, making sure they are not scared or anxious. Remind your child that you and their teacher want them to try their very best. Also, take a practice test with them and make sure your child gets a good night's sleep and a nutritious breakfast before a CAASPP/ELPAC test.

Once your child's score results become available, they will be posted in the Aeries Parent Portal. The results will identify where your child is doing well or needs more help, so you can better support their learning at home and teachers can better support their learning in the classroom.
