


Dear SAUSD community,


### Vaccines for those 65 and older

We are continuing to supply vaccines at our school sites to SAUSD community members ages 65 and older. This past weekend, with support from our community partners, SAUSD helped provide vaccines to more than 500 community members in the 65 and older age range at Valley High School and Villa Fundamental Intermediate.

These efforts are being coordinated by our individual schools. Families can reach out to their child's school for information for registering family members ages 65 and older, while District employees 65 and older can check with their supervisors.

### Vaccines for education workers

We are working with community partner [Serve the People](#) and OC Department of Education to expand vaccinations to education workers under the age of 65 through "educator pods." The next educator pod is scheduled to open in Anaheim next week and Santa Ana the week after that. All of these pods are open to all educators, but registration through the [OTHENA app](#) is required. An education specific link will be available this Friday on the app.
