7.1 School Plan (SPSA) review and approval / Aprobar el Plan Escolar, programas

- Mr. Sandquist explained that we have to mail the SPSA one-time in January, but that it is a living document that can be edited throughout the school year.
- Ms. Urizar summarized the SPSA report. The SPSA is based on the district LCAP goals. Tier1= services for all students, Tier 2=services for students that need specific/additional support, Tier 3= targeted group students/students that are struggling the most.
- ELAC recommended additional support for our newcomer students. We will have 27 by January. Mrs. Rivera will be teaching a class to service those students.
- Jessica Trease motioned to approve; Dr. Crosby seconded, all approved.
