 Notice is hereby given that the governing board ("Board") of the Santa Ana Unified School District ("District" or "Owner") will receive sealed bids for the following project, ("Project" or "Contract"):

Project: Saddleback High School New Food Service Building & Modernization

- 2. The Project is subject to the Community Workforce Agreement for Construction, Repair, Upgrade, Renovation, Modernization, Expansion, Rehabilitation and Improvement Work projects dated June 27, 2017 entered into between the District and various labor unions (the "CWA"). The successful bidder and its subcontractors will be required by the District to be bound by the terms of the CWA section 00 73 49.
- 3. Sealed Bids will be received until **2:00 PM, January 21st, 2020** at the District Office, located at 1601 East Chestnut Avenue Santa Ana, CA 92701-6322, at or after which time the bids will be opened and publicly read aloud. Any claim by a bidder of error in its bid must be made in compliance with section 5100 et seq. of the Public Contract Code. Any bid that is submitted after this time shall be non-responsive and returned to the bidder.
- 4. Contract Documents are available at Crisp Imaging. The documents include the plans and specifications pursuant to which the Project is to be constructed and upon which the bidders are to base their bids.

The Bidder's license(s) must be active and in good standing at the time of the bid opening and must remain so throughout the term of the Contract.

- 7. The following contractors and subcontractors must be prequalified prior to bidding on this Project:
 - All Bidders, per Public Contract Code Section 20111.6;
 - Per Public Contract Code Section 20111.6, all first-tier subcontractors with the following license classifications: A, B, C-4, C-7, C-10, C-16, C-20, C-34, C-36, C-38, C-42, C-43, and/or C-46.

• In addition, per SAUSD requirements, all first-tier subcontractors, if their subcontract will be equal to or greater than \$250,000.

All prequalification questionnaires will be received until **4:00 PM, January 10th, 2020**. Any contractor that has prequalified on a District project within the past twelve (12) months may be able to satisfy the prequalification requirements for this project. To become prequalified, applications must be submitted to <u>www.PQBids.com/SAUSD</u>.

- 8. All bids shall be on the form provided by the District. Each bid must conform and be responsive to all pertinent Contract Documents, including, but not limited to, the Instructions to Bidders.
- 9. The District shall award the Contract, if it awards it at all, to the lowest responsive responsible bidder based on:

The Base Bid Amount Only

- 11. District must receive any request for product substitution a minimum of TEN (10) calendar days prior to the date of bid opening.
- 12. As security for its bid, each bidder shall provide with its bid form
 - A bid bond issued by an admitted surety insurer on the form provided by the District,
 - Cash, or
 - A cashier's check or a certified check, drawn to the order of the Santa Ana Unified School District, in the amount of ten percent (10%) of the total bid price. This bid security shall be a guarantee that the Bidder shall, within **SEVEN (7)** calendar days after the date of the Notice of Award, enter into a contract with the District for the performance of the services as stipulated in the bid.
- 13. The successful Bidder shall be required to furnish a 100 % Performance Bond and a 100% Payment Bond if it is awarded the contract for the Project.
- 14. The successful Bidder may substitute securities for any monies withheld by the District to ensure performance under the Contract, in accordance with the provisions of section 22300 of the Public Contract Code.

- 15. The successful Bidder and its subcontractors shall pay all workers on the Project not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to sections 1770 et seq. of the California Labor Code. Prevailing wage rates are available from the District or on the Internet at: <u>http://www.dir.ca.gov</u>. Bidders and Bidders' subcontractors shall comply with the registration and qualification requirements pursuant to sections 1725.5 and 1771.1 of the California Labor Code.
- 16. The District's Board has found and determined that specific item(s) shall be used on this Project based on the purpose(s) indicated in Public Contract Code section 3400(c). A full list of those items can be found at <u>http://www.sausd.us/Page/28803</u>.
- 17. The District's Board reserves the right to reject any and all bids and/or waive any irregularity in any bid received. If the District awards the Contract, the security of unsuccessful bidder(s) shall be returned within sixty (60) days from the time the award is made. Unless otherwise required by law, no bidder may withdraw its bid for ninety (90) days after the date of the bid opening.
