MINUTES

REGULAR MEETING SANTA ANA BOARD OF EDUCATION

September 13, 2011

CALL TO ORDER

The meeting was called to order at 5:10 p.m. by President Hernández. Other members in attendance were Mr. Richardson, Dr. Yamagata-Noji, and Mr. Palacio. Mr. Reyna was not present at the meeting.

Cabinet members present were Dr. Meléndez de Santa Ana, Dr. Olsky, Mr. Lopez, Mr. Bishop, Mr. Mendez, Ms. Lohnes, Mr. Dixon, and Ms. Miller.

CLOSED SESSION PRESENTATIONS

Board President Hernández asked those wishing to address the Board in matters pertaining to Closed Session to step to the podium.

There were no individuals wishing to address the Board on matters of Closed Session.

RECESS TO CLOSED SESSION

The Regular meeting recessed to Closed Session to consider confidential issues, negotiations and personnel matters.

RECONVENE OPEN MEETING

The Regular meeting reconvened at 6:35 p.m.

PLEDGE OF ALLEGIANCE

The meeting was opened with the Pledge of Allegiance, led by Jonathan Garcia, fourth grade student from John Adams Elementary School.

SUPERINTENDENT'S COMMENTS

Dr. Meléndez welcomed all present at the meeting.

Superintendent Meléndez's opening report consisted of ways SAUSD is furthering the teaching and learning process. Dr. Meléndez spoke about the Response to Intervention Strategies at the elementary school level which have added academic gains to students. Dr. Meléndez has also looked into "Data Dives" with the District Instructional Leadership Team. Each individual school and student achievement is analyzed.

Marking a special time in the history of our country, Segerstrom High School students from Ms. Mateo's U.S. History class and Mr. Bradshaw's A.P. U.S. History class reflected on 9/11 discussion and conducted interviews for a Channel 7, ABC Network special segment.

The Superintendent invited Valley High School ASB President Josue Barajas to the podium. Josue shared highlights of the week's events in commemoration of this historic occasion. A short video was shared.

Dr. Meléndez presented an excerpt from a video featuring Board Vice President Rob Richardson in observance of Constitution Day on Friday, September 16. Students will be recognizing Constitution Day and Citizenship Day to commemorate the signing of the U.S. Constitution.

Superintendent Meléndez reminded parents of the upcoming Back-to-School nights as follow:

Thursday, September 15 - Elementary Schools Wednesday, September 21 - High Schools

These Back-to-School nights serve as an opportunity for parents to meet teachers and learn about the upcoming school year as well as school policies, procedures, class assignments, and student expectations.

The annual Santa Ana Unified School District College night will be hosted by Godinez Fundamental High School on Wednesday, October 5, 2011 from 6:30 to 8:00 p.m.

The Fiestas Patrias Parade in celebration of Mexican Independence Day will take place on September 18 at 4:00 p.m. Board members including Dr. Yamagata-Noji, Mr. Richardson, and Mr. Reyna will participate in the parade along with Superintendent Meléndez.

Dr. Meléndez announced Senator Lou Correa's kickoff event sponsoring the California in Motion Health and Fitness Fair on Saturday, September 24 from 9:00 a.m. to 1:00 p.m. at Valley High School.

The third annual Closing the Latino Achievement Gap Orange County Summit will be held on Friday, September 30, 2011 from 8:00 a.m. to 3:00 p.m. at Santa Ana College's Phillips Hall. The conference will feature several informative sessions. The keynote speakers for this event include Director Juan Sepulveda, White House Initiative on Educational Excellence for Hispanic Americans; Dr. Patricia Gándara, leading UCLA researcher on educational equity and Dr. José Moreno, CSU Long Beach Associate Professor and Los Amigos President.

Superintendent Meléndez shared her experience during her first weeks at SAUSD. Dr. Meléndez has visited school sites and has met with members of the community and key constituents.

RECOGNITION

Classified Employee of the Month for September 2011 - Ernesto Dolores Lopez

The District Classified Selection Committee nominated Mr. Ernesto Dolores Lopez as the Classified Employee of the Month for September. Ernesto serves as night custodian of Santiago Elementary School. Ernesto is a hardworking, dedicated employee who has provided students with a positive learning environment as well as maintenance and safety for all students and staff. Mr. Lopez was presented with a gift card and a plaque. He was accompanied by family, friends, and colleagues.

PRESENTATIONS

Unaudited Actuals and Budget Update

Mr. Michael Bishop, Associate Superintendent, Business Services, provided an overview of budget priorities/considerations for the 2011-12 school year which included 2010-11 unaudited actuals, budget updates, cash flow updates, and enrollment updates.

Mr. Bishop stated that the reduction target has been met for 2011-12. There are no lay-offs and no significant changes from the past five months of budget updates. The 2012-13 budget challenge is expected to be more difficult than fiscal 2011-12.

Federal Jobs Bill was partially used in 2010-11 for Certificated and Classified retirement incentive, and used to restore five negotiated furlough days for site certificated and administration in the current year.

School Improvement Grant schools were required to complete a corrective action plan prior to the opening of school to maintain year two funding which included an extension of the school day for Increased Learning Time.

QEIA sites are reviewed on multiple targets including class size and API; funding is in jeopardy due to class size targets.

Dr. Tony Wold, Executive Director of Business Operations, presented information regarding Program Verification. Students that are "no show" have been inactivated from enrollment and sites are beginning the outreach process for locating these students. Staffing is budgeted based upon enrollment projections. Staff is not hired until there is a verified enrollment at the elementary and intermediate level. Discussion ensued relative to credit recovery and independent studies.

Summer Projects Update

Mr. Joe Dixon, Assistant Superintendent, Facilities & Governmental Relations provided an update of facilities work that took place this summer. A PowerPoint slide presentation was made. Building services projects included painting, pressure washing, demolition of ceiling tiles, relocation of portable classrooms, relocation of portable restrooms, parking lot striping, sewer repairs and relocation of backflow device, wall damage repairs, boiler installation, roof repair, emergency lighting installation and numerous other projects throughout the District.

Construction projects took place at five elementary schools (Davis, Edison, Heninger, Hoover and Jackson), four intermediate schools (MacArthur Fundamental, Sierra Preparatory Academy, Spurgeon and Willard; and four high schools (Century, Saddleback, Valley and Santa Ana) during the summer.

Mr. Dixon asked all members of facilities and building services present to step to the podium to be recognized for all they do.

PUBLIC HEARING

Mr. Hernández declared the Public Hearing to reopen Santa Ana Unified School District's Initial Bargaining Proposal for 2011-12 School Year to California School Employees Association Chapter 41.

ITEM 11.0 APPROVAL TO CALL FOR PUBLIC HEARING TO REOPEN SANTA ANA UNIFIED SCHOOL DISTRICT INITIAL BARGAINING PROPOSAL FOR 2011-12 SCHOOL YEAR TO CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION, CHAPTER 41

The Board received no comments from the public and the hearing was closed.

Mr. Hernández received consensus from the Board to proceed to action item 11.0 on the Board agenda, which related to the public hearing.

It was moved by Mr. Richardson, seconded by Dr. Yamagata-Noji, and carried 4-0 to approve reopening the Santa Ana Unified School District's Initial Bargaining Proposal for the 2011-12 school year to the California School Employees Association (CSEA), Chapter 41 in accordance with Government Code 3547 and Board Policy 2000.

PUBLIC PRESENTATIONS

President Hernández asked those members of the community who wished to address the Board to step forward as he called their names:

Marianne Monfils, CSEA Labor Relations Representative for classified employees, addressed the Board regarding THINK Together. The Court will be issuing a decision at a hearing on October 28 regarding the validity of the existing THINK Together agreement. Ms. Monfils asked that the District to delay entering into a new agreement with THINK Together. She stated that CSEA opposes any new program that will eliminate or displace classified positions. Ms. Monfils addressed concerns relative to SAUSD employees. Ms. Monfils informed the Board that if they do not settle the current lawsuit prior to October 28, the District could face a court ruling that would void the THINK Together contract.

Jonathan Espinoza and Ruby Mejia, Segerstrom High School students, addressed the Board regarding a recent policy regarding textbook sets for teachers. Jonathan said he was aware of the financial crisis we are in and knows the importance of education. AVID does not have textbooks and, therefore, interferes with instruction without the proper resources. Jonathan and Ruby demonstrated to the Board how students have to carry a backpack along with an additional bag if they are in athletics.
