SUPERINTENDENT'S REPORT

Superintendent Almendarez shared that a vaccine clinic was held at Willard Intermediate School for about 200 SAUSD students ages five to 11, the first clinic at any of our school sites for children five and older. He added that the District's goal is to host similar clinics at other schools for all eligible children and adults in the days and weeks to come. He thanked Albertsons for sponsoring the clinic and also thanked all the SAUSD staff who work to organize these clinics. Information on future clinics will be provided through ParentSquare, on saUSD.us, and on district social medial channels. Mr. Almendarez encouraged everyone as they prepare for the holiday season to follow all guidelines for travel and for large gatherings, put in place by local, state, and federal health care agencies. The district will soon provide an update for families and staff with the latest rules for quarantining after travel, and other recommendations to help us stay safe during this holiday season. Superintendent Almendarez also shared that the fourth public hearing was held last night at Century High School on the proposal to establish Trustee Areas and elections By-Trustee Areas. Community members had an opportunity to review and offer input on three proposed maps to determine Trustee areas. There is one remaining public hearing scheduled for Monday, December 6 at Segerstrom High School. He encouraged parents, residents, and/or voters who reside within the SAUSD district boundaries to participate in this remaining meeting. He invited everyone to visit www.sausd.us for more information on this important process. Superintendent Almendarez also invited all SAUSD Native American families to participate and offer input on how this community can be better served by attending the Native American Family Outreach Night on Friday, November 19, from 4:00 - 7:00 p.m. at the District office.

BOARD REPORTS

Mrs. Amezcua thanked speakers on testing and COVID. She asked for clarification on testing. Mrs. Amezcua addressed the Superintendent regarding the grading policy. Mrs. Amezcua asked for PPE for band members. She commented on Superintendent's proposal for Shared Studios. Mrs. Amezcua also addressed the District election meetings and added that we should be meeting with all community groups such as neighborhood associations, school site councils, PTA's, PTO's, and staff. She also commented on the hiring of a teacher at Cal State Long Beach.

Mr. Palacio congratulated Sal Tinajero, support staff, school sites, and students for the work they are doing and encouraged that we continue the Speech and Debate program. He shared that he attended the Segerstrom and Santa Ana High School playoff games and congratulated the teams. He commented on how it is very important that we know what the RFP thresholds are and how the consent calendar is being used. Mr. Palacio added that contracts must conform to a certain standard. He clarified that there is signature authority for Mr. Magnuson, temporary hires, and Mr. Koyama. He requested additional information on the Maxim staffing agreement. Mr. Palacio commented on the recent payroll overtime and extended duty update on the personnel calendar, however, a lot are still back dated up to 4 months. The District needs to catch up and make everyone whole.

Dr. Alvarez thanked all public speakers and asked Superintendent to follow up on library services. He shared that last Tuesday, NJROTC was recognized by city council. This year they are celebrating 50 years and have earned national distinguished designation and now in the top 10% in the nation. He also shared that last Friday there were two CIF games, Segerstrom and Santa Ana High School. Santa Ana High School won their game and will be playing their second round at Dominguez High School in Compton. Dr. Alvarez added that last Thursday, he attended a neighborhood meeting around MacArthur traffic flow. He thanked Orin for sending staff members. He mentioned that he has heard from other city council members, constituents have been complaining about traffic flow. He asked if the District could take another look at the traffic flow. Lastly, he recognized staff who are veteran.

Ms. Torres shared that she and Dr. Alvarez attended a televised city meeting. She added that there was confusion on roles and are in preliminary stages but are committed to have equal power in this space. Mr. Torres stated that she is glad that COVID rates are down and that the community is getting vaccinated, however, is staying optimistic

until after winter. She thanked the City Council for passing the Just Cause Eviction Rent Controls. She echoed the concerns on the partnership insurance on partnership agreements from 1 to 3 million specifically on the smaller organizations. Ms. Torres announced a documentary showing with Chicanos Unidos about the handball courts removal in the city and mentioned issues with handball courts in the schools. It was also about the gentrification of the Main Street corridor which is going to have some effect on the schools and the families as well and about the parking issues for the District.

Dr. Rodriguez thanked the City Council for the Rent Control Just Cause policy that was passed. He shared COVID numbers with the community and said that it is important that we don't let our guard down. He asked for a legal statement to be clear on what is a consent item and what is an action item. Dr. Rodriguez acknowledged the Speech and Debate team. He requested updates on Title 7 and announced the Native American Family Outreach Night on Friday, November 19. Lastly, he stated that he supports the request that Eddie Leon made for a session or working committee to understand how LCAP translates into budget priority.

The Regular Board meeting recessed to closed session at 9:45 p.m. to discuss personnel matters, existing litigation, and anticipated litigation.
