CALL TO ORDER

Board President Torres called the meeting to order at 5:04 p.m.

Other members in attendance were Dr. Alvarez, Mr. Bustos, Ms. Brazer Aceves, and Dr. Rodriguez.

SUPERINTENDENT'S REPORT

Superintendent Almendarez announced Black History Month as a time to celebrate the contributions and achievements of Black Americans throughout our country's history. He shared that it is a reminder of the resilience and determination of those who have overcome adversity and discrimination to make a lasting impact on our society and highlighted the importance of educating our students about the important role Black Americans have played in shaping the of our nation. He asked that we use this month to not only honor the past, but to also inspire future generations to continue the legacy of progress, equality, and justice for all. Mr. Almendarez also announced that the first week of February was National School Counselor Week. This is a time to celebrate the dedicated professionals who support and guide our students on their educational journeys. He shared that our school

counselors play a critical role in helping students navigate the challenges of academic, social, and emotional growth, and it is essential that we recognize and appreciate the work they do. School counselors help our students build the skills and resilience they need to succeed in school and in life. He recognized Monica Mejia, counselor at Segerstrom High School, who was named as one of five 2023 Orange County School Counselors of the Year by the County Department of Education. He invited everyone in congratulating Ms. Mejia and all of our amazing SAUSD counselors.

Mr. Almendarez announced that the District will be hosting a series of town hall meetings over the coming weeks as part of our effort to provide ongoing information regarding the District's budget process. The goal for these town hall meetings is to share with our SAUSD community how the District is funding various initiatives to support our Board priorities that help meet the academic needs and well-being of our students. We will also highlight our different revenue sources, and how funding for SAUSD can vary each year depending on several external factors. He added that our SAUSD team will be available to answer questions about the budget process from our community. The first of these series of meetings will be on February 23 here at the district office from 9:00 to 10:30 a.m. and at Willard Intermediate School from 6:00 - 7:30 p.m.

Superintendent Almendarez invited everyone to our We Care campaign community resource fair tomorrow evening at Santa Ana High School. This event will bring together community organizations and resources dedicated to promoting mental wellness for our students and families. He added that mental health is a crucial aspect of overall health and well-being, and it is our responsibility as educators to ensure that our students have access to the support they need. He shared that the resource fair will offer something for everyone and added that he is very grateful to the community organizations and resources that are partnering with us to make this event a reality. Together, we can build a stronger, more resilient community that prioritizes the mental well-being of all its members. Mr. Almendarez announced that as part of the We Care Resource Fair, our District's Visual and Performing Arts department will be showcasing this year's Lit Con festival Wednesday, February 15, 2023 from 5:30 - 7:30 p.m., where students from across the district will be performing poetry, prose, and other spoken word activities from here in our board room during the resource fair. All performances will also be live streamed on channel 31, saUSD.live, and our SAUSD YouTube channel.

NEW AND REVISION OF EXISTING BOARD POLICIES - FIRST READING/NO ACTION REQUIRED

12.1 Board Policy (BP) 1012 – Complaints Against District Employees (Revised: For First Reading)

BOARD REPORTS

Dr. Rodriguez acknowledged the public presentations and parent comments regarding their concerns about a teacher's suicidal ideation and added that teachers and staff also experience mental health struggles. It is why we need to find a way to support the teacher, the administrator, and the staff to make things right and to recognize if we didn't do something the way we should have. He thanked all the counselors that spoke and highlighted the importance of having a smaller ratio of students to counselor. In regards to the parent that spoke on Special Education, he requested a summary of the questions that parents brought up at meetings during winter and spring of the 2021-22 school year and how those issues were addressed. In addition, he asked that we add committees to the Board Governance agenda to map out all the different committees the District has and to know which ones are appropriate for Board members to attend.

Ms. Brazer Aceves wished everyone a happy School Counselors Month. She thanked counselors and parents that spoke during public comments. Ms. Brazer Aceves shared that she attended the Orange County Department of Education sponsored School Counselor Symposium. She congratulated Ms. Mejia, the counselor at Segerstrom High School, who was named as one of five 2023 Orange County School Counselors of the Year. Ms. Brazer Aceves highlighted the new high school graduation requirement for students to apply for FAFSA or California Dream Act. She added that if there are any questions regarding these applications, our School Counselors and Higher Education Coordinators are available. In addition, students and families can contact the College and Career Readiness Department 714-558-5871. Ms. Brazer shared that Ms. Mia Verdin invited her to the Santanero Project, who hosted a community space to get feedback. She thanked the District for inviting the Board to the Fiestas Mexicanas event at Santa Ana High School. She also attended the Lydia Romero Cruz Academy Grand Opening of the new kindergarten classrooms and playground and thanked Mr. Williams and his team for the tour. She highlighted the "We Care" suicide prevention campaign which was recognized by the City of Santa Ana. She uplifted

the Superintendent, Dr. Llamas, and the team for their work around mental health and suicide prevention. Lastly, she shared that The Seva Collective had a food drive last Saturday where hundreds of families were being served fresh produce. Their next drive is on February 25 at Villa Fundamental Intermediate School.

Mr. Bustos wished everyone a Happy Black History Month and shared that this is the time to celebrate and recognize the contributions of the African American community to this country and to this community as well as the adversities and injustices. Mr. Bustos also shared that he will be joining SAUSD at Santa Ana High School for the "We Care" Resource Fair from 5:30 – 7:30 p.m. He shared his love and support for the LGBTQ+ community and addressed the issues they are facing such as the having a motion to remove the pride flag in Huntington Beach. There is also the issue of virtual libraries being taken down. He stated that everyone is welcomed and supported in Santa Ana. Mr. Bustos was proud to have joined Ms. Brazer Aceves at the dedication ceremony at Lydia Romero Cruz. He highlighted the suicide prevention presentations being held for parents. There is one coming on February 23 from 9:00 - 10:00 a.m. and 5:30 - 6:30 p.m. at the Rob Richardson Welcoming Center. He announced the budget town halls as stated in the Superintendent's report and recognized all the school counselors. Lastly, he asked for information on what meetings Board members can go to, as Special Education is very important to him.

Dr. Alvarez gave a shout out to all school counselors and announced the "We Care" Resource Fair from 5:30 - 7:30 p.m. at Santa Ana High School including the LitCon Festival.

Ms. Torres acknowledged School Breakfast Week and the nutrition workers and staff who make our breakfast programs happen. She highlighted the Black Panthers parallel programs that were established in the 1960's. There is some debate on who came first and who influenced who, but they were major programs in 1969-1970. There were 23 cities that adopted the program through the Black Panther party and served twenty thousand kids. She thanked the Board members that were able to attend the dedication ceremony at Lydia Romero Cruz. She thanked the Board for approving the land acknowledgement resolution. She echoed other Board member's comments on the mental health of our staff and asked that we begin to have conversations to address the process by which they are being addressed. Ms. Torres acknowledged the counselors and thanked them for the cookies. Ms. Torres announced the anniversary of the Mendez vs. Westminster case in April but the case was actually argued in February. This has cultural and historical significance. She shared that there is a memorial in Westminster and OCDE is offering tours for educators and students with lesson plans. Ms. Torres asked the District to verify if they have apologized for the segregation of Mexican children in Orange County and would like to start the process to do so by April. She asked for Board consensus and there was no opposition. She also echoed the sentiments on committees Board members should attend and asked for a list. She announced that there is an ethnic studies conference in April and is waiting for a flyer. Ms. Torres asked for an update on the Farm to Schools Program, its impact on nutrition workers, and what kind of curriculum or content is being done at school sites, and what supports we are providing. She affirmed her stance against book bans and censorship of knowledge an attempt to undo the gains in representation in literature. Dr. Rodriguez added that we should begin the process to develop a stance against book banning and asked for Board consensus. There was no opposition.

ADJOURNMENT

There being no further business to come before the Board, President Torres adjourned the meeting at 9:23 p.m.







SCOPE:

The Board of Education desires to prepare all students to obtain a high school diploma to enable them to take advantage of opportunities for postsecondary education and/or employment.

POLICY:

Credit Requirements

Minimum academic standards for graduation from senior high school in the Santa Ana Unified School District beginning with the Class of 2009 are as follows:

- Satisfactory completion of a minimum of two hundred and twenty (220) semester periods of credit.
- Semester credit and the time or content equivalency mean:
 - One period of forty (40) to sixty (60) minutes of instructional time per week throughout one semester or no less than seventeen (17) weeks is the equivalent of one semester credit.
 - A minimum of twelve (12) clock hours of instructional time provided during the academic year or in a summer school is the equivalent of one semester credit.

In certain cases, with prior approval of the principal, credit may be assigned when equivalent learning is achieved through individualized instructional programs except in subjects for which a minimum of instructional time is specified by law.

Course Requirements

All courses required for high school graduation shall be aligned to District and State standards, where applicable.

To obtain a high school diploma, students shall complete the following courses in grades 9-12, with each course being one year unless otherwise specified. Santa Ana Unified School District (SAUSD) has aligned the high school graduation requirements to meet A-G eligibility requirements, including validation rules specified by the California State University (CSU) and the University of California (UC) systems.

1. English 4 years (40 credits) which can include UC approved courses and classes taken in a foreign country. (Education Code 51225.3)
2. Mathematics 3 years (30 credits) including Algebra I and Geometry. Completion of such coursework prior to grade 9 shall satisfy the Algebra I or Mathematics I requirement, but shall not exempt a student from the

requirement to complete two mathematics courses in grades 9-12. (Education code 51224.5)

Students may be awarded up to one mathematics course credit for successful completion of an approved computer science course that is classified as a “category c” course based on the “a-g” course requirements for college admission. (Education Code 51225.3, 51225.35)

Validation rules apply, as specified by the CSU and UC systems.

3. Science 2 years (20 credits) including one course of Biology/Life Science and one course of Physical Science.

4. Social Science 3 years (30 credits) including World History, Culture and Geography (10 credits); U.S. History and Geography (10 credits); Principles of American Democracy (5 credits); and Principles of Economics (5 credits).

5. World Languages or Language Other Than English (LOTE) 2 years (20 credits) in the same language. Courses in languages other than English taken in seventh and eighth grades may be used to fulfill part of the requirement.

Validation rules apply, as specified by the CSU and UC systems.

6. Visual and Performing Arts 1 year (10 credits) in year-long sequence in a single area (dance, drama/theater, music, or visual arts) requiring the first semester as a prerequisite.

7. College and Career Planning/Technology Student Skills/College and Career Planning to be included in the intermediate and high school curriculum.

Technology Technology shall be integrated throughout the intermediate and high school curriculum. Technology requirements shall be met through a District approved demonstration of technological competence.

8. Physical Education 2 years (20 credits) unless the student has been exempted. (Education Code 51225.3)

9. Ethnic Studies 1 year (10 credits) beginning with the Class of 2026, one year-long course of Ethnic Studies. (Education Code 51225.3)

The Ethnic Studies requirement can be fulfilled through the successful completion of a qualifying course that meets the District's Ethnic Studies specifications. (Education Code 51226.7)

10. Financial Aid

Completion of the Free Application for Federal Student Aid (FAFSA) or California Dream Act Application (CADAA) is required for high school graduation. The parent or legal guardian of the pupil, or the pupil if the pupil is a legally emancipated minor or 18 years of age or older, may opt out of the requirements by completing and submitting an opt-out form. (Education Code 51225.7)

A foster youth, homeless student, former juvenile court school student, child of a military family, migrant student, or newly arrived immigrant student participating in a newcomer program who transfers into the District any time after completing the second year of high school shall be required to complete all graduation requirements specified in Education Code 51225.3 but shall be exempt from any additional District-adopted graduation requirements, unless the Superintendent or designee makes a finding that the student is reasonably able to complete the requirements in time to graduate by the end of the fourth year of high school. Within 30 days of the transfer, any such student shall be notified of the availability of the exemption and whether the student qualifies for it. (Education Code 51225.1)

Retroactive Diplomas

Any student who completed grade 12 in the 2003-04 through 2014-15 school year and met all applicable graduation requirements other than the passage of the high school exit examination shall be granted a high school diploma. (Education Code 51413)

In addition, the District may retroactively grant high school diplomas to: (Education Code 48204.4, 51430, 51440)

1. Persons who departed California against their will, while in grade 12, and did not receive a diploma because the departure interrupted their education, provided that they were in good academic standing at the time of the departure.

Persons may be considered to have departed California against their will if they were in custody of a government agency and were transferred to another state, were subject to a lawful order from a court or government agency that authorized their removal from California, were subject to a lawful order and were permitted to depart California before being removed from California pursuant to the lawful order, were removed or were permitted to depart voluntarily pursuant to the federal Immigration and Nationality Act, or departed due to other circumstances determined by the District that are consistent with the purposes of Education Code 48204.4.

In determining whether to award a diploma under these circumstances, the Superintendent or designee shall consider any coursework that may have been completed outside of the United States or through online or virtual courses.

2. Former students who were interned by order of the federal government during World War II or who are honorably discharged veterans of World War II, the Korean War, or the Vietnam War, provided that they were enrolled in a district school immediately preceding the internment or military service and did not receive a diploma because their education was interrupted due to the internment or military service in those wars. Deceased former students who satisfy these conditions may be granted a retroactive diploma to be received by his/her next of kin. (Education Code 51430)
3. Veterans who entered the military service of the United States while in grade 12 and who had satisfactorily completed the first half of the work required for grade 12 in a district school.

Honorary Diplomas

The Board may grant honorary high school diplomas to:

1. An international exchange student who has not completed the course of study ordinarily required for graduation, and who is returning to the home country following the completion of one academic school year in the District.
2. A student who is terminally ill.

The honorary diploma shall be clearly distinguishable from the regular diploma of graduation awarded by the District. (Education Code 51225.5)

DESIRED OUTCOME:

This revised Board policy ensures that students meet the requirements for a high school diploma and graduate from the Santa Ana Unified School District ready for post-secondary education and/or employment.

SCOPE:

Annual Organizational Meeting

Each year, the Governing Board shall hold an annual organizational meeting. In any year in which a regular election of district Board members is conducted, the organizational meeting shall be held within a 15-days following the second Friday in December after the regular election. During all other years, the meeting may be held on any date in December, but no later than December 20th. (Education Code 35143)

POLICY:

During any year in which a regular election is conducted, the Board, at the regular meeting held immediately prior to the second Friday in December, shall select the day and time of the organizational meeting. For any other year, the day and time of the organizational meeting shall be selected at the last regular meeting held immediately before the annual meeting. On behalf of the Board, the Superintendent shall notify the County Superintendent of Schools of the day and time selected. Within 15 days prior to the date of the annual meeting, the Superintendent shall notify in writing all Board members and members-elect of the date and time selected for the meeting. (Education Code 35143)

At this meeting the Board shall:

1. Elect a president and a clerk and/or vice president from its members
2. Appoint the Superintendent as secretary to the Board
3. Authorize signatures
4. Approve a schedule of regular meetings for the year and a Board governance calendar stating the time when the Board will address important governance matters
5. Designate Board representatives to serve on committees or commissions of the district, other public agencies, or organizations with which the district partners or collaborates
6. Review and/or consider resources that define and clarify the Board's governance and leadership roles and responsibilities including, but not limited to, governance standards, meeting protocols, Board rules and bylaws, and other Board development materials
