PLEDGE OF ALLEGIANCE

The meeting was opened with the Pledge of Allegiance led by Mr. Tinajero.

SUPERINTENDENT'S REPORT

Dr. Mijares drew to the attention of those present the artwork posted from Grant and Taft Elementary Schools and Mendez Fundamental Intermediate School.

Dr. Lewis Bratcher, Assistant Superintendent, Secondary Education, introduced Santa Ana High School's Head Wrestling Coach, Scott Glabb. Mr. Glabb then acknowledged three Santa Ana High students who competed in the State Finals: Jose Serrato, CIF Champion, Jose Hernandez who finished Second in CIF, Second in the Masters, and was a point away from placing in the State Championship, and Rudy Justo, who finished Second in CIF, Seventh in Masters, and a few points from placing in the State. Board and Superintendent commended students for their accomplishments.

Dr. Bratcher then called upon Mr. Frank Pinto, Valley High School Head Wrestling Coach, who introduced student Luis Pallanes. He said that Luis Pallanes also competed at the State Finals with Santa Ana High students. Mr. Pinto attested to the remarkable determination of Luis. The student had open heart surgery a few years ago and he came back to finish fourth in the Masters and a few points from State Finals. Board and Superintendent commended Luis for his determination and a job well done.

Mr. Jose Sanchez, Head Soccer Coach, Valley High School, announced that the Valley High School Varsity Soccer Team won the Division IV CIF

Soccer Championship for the 2004 School year. Players received commendations for their diligence and hard work. The Board, Dr. Mijares, and Cabinet congratulated the team and said that Valley High School last won a Championship in 1974. Students receiving recognition were Luis Abrajan, David Aguilar, Alonso Vicente, Luis Alvarez, Federico Barajas, Eduardo Blanco, Christian Borquez, Gabriel Buenrostro, Felix Cruz, Santiago Cruz, Cristian Fonseca, Gilberto Gonzales, Christopher Hernandez, Joe Hernandez, Jose Jacobo, Jonathan Maldonado, Marcos Meza, Richard Morfin, Jorge Munoz, Cesar Sanchez, Juan Tolento, Elmer Vega, and manager Alejandro Barbosa.

Dr. Bratcher then introduced Santa Ana High School Principal Mr. Salcedo, who called upon student Gloria Montiel who was in attendance to represent the Santa Ana High School Speech and Debate Team. She said that the finals proved Santa Ana High School's force in the State competition which qualified them for the State. Students Joanna Garcia and Luis Marion came in first in the league, Jarred Allen and Omar Chavez, came in fourth, and Gloria Montiel and Hong Len came in fifth, which qualified them for State competition. There are only five teams that qualified from Orange County and Santa Ana has three of the five teams. Dr. Mijares and Board congratulated them for an exemplary job.

Dr. Mijares then introduced Ms. Stacy Kline, a Spurgeon Elementary teacher, who introduced three students David Hernandez, $6^{\rm th}$ grade; Linda Ly, $8^{\rm th}$ grade; and David Rodriguez, $8^{\rm th}$ grade. A brief presentation summarized the award-winning technology program at Spurgeon Intermediate and noted that students are technology trainers for other students. She then provided information on the Southern Section Leadership Conference where Spurgeon's FBLA was recognized as $3^{\rm rd}$ Place winners for the Charles Dee Cox Nametag Award. Student David Rodriguez stated that he and Linda Ly were crew leaders of the Studio Team and were selected by the O.C.D.E. to represent the SAUSD in the Student Technology Showcase in which they had to produce a documentary. Students then presented to Board their technical attributes to the program.

A groundbreaking ceremony helps the Santa Ana Unified commemorate the legacy of Hector G. Godinez. Board members, dignitaries, SAUSD staff, and Godinez family members attended the groundbreaking ceremony in honor of Mr. Hector Godinez in which the future school was named after. Hector G. Godinez Fundamental High School High School Project is composed of land that has been acquired from the City of Santa Ana and the Centennial Heritage Museum through the use of joint use agreements. The Project is being constructed on 5.89 acres. The school is expected to be completed in January 2006.

The Superintendent was honored to celebrate the academic achievements of four Santa Ana Unified students at a breakfast celebration held by the Association of California School Administrators or ACSA. Each of these students received the 2004 "Every Student Succeeding" award. The recipients were as follows: Carlos Tejada from Martin Elementary and Ivette Giles, Juan Oliveros, and Nancy Ramirez from Mountain View High School. Students received a certificate and a cash award and were accompanied to the breakfast by their parents.

Update on Safe Schools Healthy Students Grant

School Police Chief Jim Miyashiro presented information concerning the Safe Schools Healthy Students grant. He said that the program has many components, resources, and services available for students and families within the Santa Ana Unified School District. Barbara Cummings, Coordinator of Special Education Services; Maria Mojarro, Administrator; and Gayle McLean, Director Nurse Services presented key grant elements. Chief Miyashiro began by reading the Mission Statement. He then summarized the grant background. He said that in September 2002, the SAUSD was one of 46 school districts in the nation to receive approximately \$9 million through the Safe Schools Healthy Students grant, with an additional \$750,000 to fund sworn School Resource Officers through the U.S. Department of Justice. The three-year grant targets area IV and funds specific wideranging services that would otherwise not be funded through the District's General Fund. The initiative is a comprehensive community-wide collaboration dedicated to fostering the healthy development of children in partnership with law enforcement, mental health, community agencies, the City, parents, and students. A long-term, strategic plan will be developed to provide the resources and tools needed to reduce school crime, drug use, violence, and mental health. The partnership is funded by the Federal Department of Education, Health and Human Services, and Justice Department to focus on three primary goals which are community-wide safe and drug free schools; the support of healthy childhood development, and reduce drug use and violence.

The following information concerning the six elements of the grant was presented by Ms. Cummings, Ms. Mojarro, and Ms. McLean are as follows:

Element One:

- First Aid training and first responder training

The Board thanked District staff for an informative presentation. Mr. Richardson requested copies of the PowerPoint presentation to be sent to Board members in Week-in Review.

PUBLIC COMMENTS

Dr. Mijares provided an explanation concerning the reduction of staff and letters of notice required by law. He said that, in the past two years significant budget adjustments have occurred in the District due to the severe decline in revenue from the State of California and a drop in student enrollment. He explained that Assembly Bill 1200 is a financial accountability law which requires school districts to maintain positive fund balances for the current year and two subsequent years. He stated that unrestricted money received from the State falls under the discretion of the Board and that the law mandates certain types of expenditures such as class size and number of teachers. It is common to have 85-90% of funds committed to staffing. Therefore the District has no other recourse but to look at reducing employment services in order to maintain the revenue limits required by law. Furthermore, he stated that in October, the SAUSD approved a multi-year financial plan which demonstrated to the County and the State that the SAUSD would make the necessary reductions in order to be in compliance with AB1200. He said that the passage of Proposition 57 and 58, guarantees a 1.84% COLA, which will bring in new revenue. Also, the SAUSD reached a tentative agreement with the SAEA, which received an affirmative vote of approximately 80% of certificated staff voting. The tentative agreement is on the Agenda tonight which if passed, would generate ultimately approximately \$10 million. This would allow the District to restore critical services which includes over 100 certificated positions. He said that in Closed Session the Board authorized the restoration of 95 certificated positions. These positions will be in the areas, but not limited to music and art, counseling, nurses, and ROP programs.

Mr. Richardson asked those members of the community wishing to address the Board to step to the podium as their names were called. He stated that due to the number of speakers, that one minute would be provided to each person.

RATIFICATION OF NEGOTIATED SETTLEMENT FOR THE 2003-04 AND 2004-07 SCHOOL YEARS WITH SANTA ANA EDUCATORS' ASSOCIATION (SAEA)

Mr. Best was called upon to speak about the negotiated contract. He introduced Mr. Ron Wenkart, OCDE General Counsel Legal Services, and Mr.

Ron Bennett, with California School Services, who serves as a financial expert. Mr. Best provided a brief summary concerning the item. He said that tentative agreements have been reached with SAEA for the 2003-04 and 2004-07 contracts. A settlement agreement was ratified by a combined vote for 2003-04 which received 1,804 yes votes at 80.6% and 433 no votes at 19.4%. For the 2004-07 received were 1,740 yes votes at 77.8% and 495 no votes at 22.2%. Mr. Best stated that there were 22 items on the table being negotiated. The focus was on the instructional day, evaluations, and waivers.

Mr. Ron Bennett explained the impasse process which was declared by the District and stated that tonight was a result of the negotiations. Mr. Bennett stated that the significant concessions by the employee organization were a tremendous help toward solving the financial problem and that the ratification of the contract on the Agenda tonight is appropriate.

Mr. Richardson asked what to expect if the ratification took place tonight. Mr. Bennett responded that the District would have achieved the \$9 million in savings and the District would be able to restore particular kinds of services eliminated previously and that the District would be on track financially. If the Board does not ratify the contract, positions would not be restored; fact finding would be required, and negotiations would continue. The likelihood of receiving an agreement as the current one is almost impossible. Mr. Bennett would have to advise the county to change the certification to a negative.

Mr. Tinajero inquired about the timeframe in terms of fact finding. Mr. Bennett responded that the fastest tract would be within a week or two. There would be two or three sessions before determining the release to fact finding, which would be the end of April. PERB would appoint a neutral chairperson which would be the first of May, the hearing would be held within 10 days and a report would be ready by mid-June, then finalized within a month or two following.

Mr. Richardson asked how the fact finding process affects the May 15 deadlines to rescind notices. Mr. Bennett responded that the elimination of positions would take effect and the certification would result in a negative.

Dr. Mijares referenced the matter of domestic partner benefits and explained that this was a condition of State law and a proposal in the new contract. He then called upon Mr. Ron Wenkart to explain the laws enacted by legislature that employers must follow.

Mr. Wenkart stated that there have been changes in the State law concerning the status of domestic partners. It is requested by the State that employers provide benefits for family leave and sick leave for domestic partners. He provided information on Assembly Bill 205 as follows:

- Bill amends various provisions of the Family Code and Government Code relating to domestic partners. Key portions of the legislation take effect on January 1, 2005
- It is known as the California Domestic Partner Rights and Responsibilities Act of 2003
- It modifies existing procedures for the establishment and termination of domestic partnerships and requires additional duties of the Secretary of State

- It would extend the rights and duties of marriage to a persons registered as domestic partners on or after January 1, 2005
- States that the purpose of the legislation is to provide all caring and committed couples the opportunity to obtain essential rights protections and benefits, to assume corresponding responsibilities, obligations, and duties and further the state's interest in promoting stable and lasting family relationships.

Mr. Wenkart then provided two provisions in Family Code section 297.5:

- Registered domestic partners shall have the same rights, protections and benefits and shall be subject to the same responsibilities, obligations and duties under law as are granted to and imposed upon spouses.
- Former registered domestic partners shall have the same rights, protections and benefits and shall be subject to the same responsibilities, obligations and duties under law as are granted to and imposed upon former spouses.

Mr. Richardson asked what the expense or impact would be to the District. Mr. Best read a section of a letter from Mercer, the District's employee benefits program, which indicated that health rates would not be increased.

Mrs. Avila thanked the teachers for working diligently to settle the contract and for the She also expressed her belief on the issues presented tonight concerning the item. She encouraged the Board to move forward with education with the right values. Mrs. Avila recommended approving the contract with the elimination of the domestic partnership benefits.

Dr. Yamagata-Noji stated that she appreciated the parents, teachers, and community members' thoughts, passion, and opinions. She was moved by parents and students speaking about the music program. She said that the Board is working diligently to restore positions and urged that staff work expediently in sending out the rescission letters. She stated that Board is sensitive to every request and must make certain that the District is always in compliance. She concluded in saying that one should not cast judgment to another, but be respectful to all.

Mr. Tinajero stated that he believes that one should not pass judgment and we should reevaluate ourselves. He explained that each school has one or more SAEA representatives then described the voting process. He said that when he was sworn in as a Board member he swore to uphold the law. As a believer he will not judge, but strive to achieve what one should be.

Mr. Palacio thanked teachers for their share of responsibility regarding the fiscal crisis. He said that he believes that this is about accountability. He stated that the SAUSD is the only district that FCMAT is assisting. He questioned the fiscal problems the District continues to face and believes that information provided to the Board and community has not been accurate. He also questioned the dissemination of the proposed agreement and why Board hadn't received information sooner. He further stated that the District previously received knowledge of declining student enrollment. He asked that District take responsibility and end what he believes is a spin game. He stated that SAUSD is the only District that is cutting beyond the impact of the State and management must take a share in that responsibility.

Mr. Richardson commented on the accountability and action of the Board. He stated that the responsibility is shared by the current Board, previous Board, and staff. He stated that many aspects caused the economy to suffer. Rising health benefits costs, workers' compensation costs, and step and column costs, declining student enrollment (forecast showed two years from now), and 911. He said that he cannot imagine a more irresponsible action than to fail to ratify the agreement presented tonight. He stated that there is too much at stake to play politics. He said that by reading the newspaper, there are many communities that have not recovered and said that he would not allow that to happen in the SAUSD.

It was moved by Mr. Richardson, seconded by Dr. Yamagata-Noji, and carried 3-2, Mrs. Avila and Mr. Palacio dissenting, to ratify the negotiated settlement for the 2003-04 and 2004-07 school years with Santa Ana Educators' Association.
