Tuesday, March 9, 2021

CALL TO ORDER

Board President Rodriguez called the meeting to order at 5:02 p.m.

Other members in attendance were Ms. Torres, Dr. Alvarez, Ms. Amezcua, and Mr. Palacio.

CLOSED SESSION PRESENTATIONS

Dr. Rodriguez asked if there was anyone wishing to address the Board related to closed session items.

There was no one wishing to address the Board.

RECESS TO CLOSED SESSION

The Regular Board meeting recessed to closed session at 5:02 p.m. to consider existing litigation, personnel matters, negotiations, and real property negotiations.

RECESS TO REGULAR MEETING

Closed Session recessed to the Regular Board meeting at 6:18 p.m.

RECONVENE REGULAR MEETING

The Regular Board meeting reconvened at 6:25 p.m.

Executive Cabinet members in attendance were Superintendent Almendarez, Ms. Corridan, Dr. Perez, Ms. Barquin, Dr. Helguera, Dr. Llamas, Dr. Martinez, Mr. Roychowdhury, Mr. Williams, and Chief Smith.

PLEDGE OF ALLEGIANCE

Superintendent Almendarez led the Pledge of Allegiance.

REPORT OF ACTION TAKEN IN CLOSED SESSION

By a vote of 5-0, the Board took action to approve the recommended non-reelected probationary certificated employee as named in closed session, ID# 34595, effective June 5, 2021.

SUPERINTENDENT'S REPORT

Superintendent Almendarez provided an update on COVID case rates. In Santa Ana, the testing positivity rates are now between 3% and 8% in every zip code. This is a dramatic drop from just a couple of months ago when zip codes were within 30% range. Today, Orange County is still in the Purple Tier, but if the numbers continue to decline, Orange County will most likely fall to the Red Tier by next Tuesday, March 16. This means several restrictions including gatherings, outdoor dining, and traveling will start to ease. He cautioned everyone that three of the six SAUSD zip codes remain within the Purple Tier case range and asked everyone to follow all safety measures. Superintendent also addressed the CIF's guidelines for Return to Play. The District has been trying to get as many sports running as possible. A few of them have been practicing like football. There was news released today about loosened restrictions for other athletic programs. He also addressed questions by parents and community members about allowing spectators at these events. This afternoon the new county numbers came in below the 7% threshold. If that remains the same until March 16, the entire county will move into the red tier which will allow the District to reconsider some of the restrictions that have been implemented across the District. The District has been trying that no spectators would be allowed at sporting events. As a result of the numbers going below the threshold, the District will now reconsider allowing each athlete to have 2 spectators. He also shared that he had the opportunity to meet with Santa Ana, High School's football team and coaches today and answered a few of their questions.

Superintendent Almendarez also addressed questions about the reopening plan. He stated that the Governor issued a new ruling on SB 86 Funding for Return to School Incentive Grant and asked the Board for permission to bring back the SB 86 back to the Board. SB 86 is funding from the state that is designed to encourage return to in person instruction. Learning labs are taking place at the school sites. The next phase would be for students to return to supervised campus with small learning cohorts and small learning groups. The plan is to get to a cohort model for in person instruction. The timing is based upon COVID rates and information on student's willingness to return to campus or to remain in distance learning. Superintendent would like to present the reopening plan and SB 86 and what that means to the District. Dr. Alvarez asked that the data be really clear as it relates to Santa Ana. Ms. Amezcua asked that the information be brought back in buckets, first with elementary and then work their way up. She also asked Superintendent to include how the needs of special education students will be addressed. Ms. Torres asked for compelling and thorough information. Dr. Rodriguez asked that the information be brought back to the March 23, 2021 Board meeting and also asked the Superintendent to engage with the Board members individually before that time. Mr. Palacio asked that staff meet with the bargaining units and to survey employees and families on where they stand on this issue.

Mr. Almendarez gave a report on the vaccines. He gave a shout out to Ms. Amezcua for her work behind the scenes with community leaders to get vaccines to employees. The District has secured and offered 4,700 vaccines for SAUSD staff. Vaccines have also been offered to 3,000 SAUSD family members ages 65 and above through community PODs. This is in addition to all the SAUSD community members and staff who have received vaccines through the countywide and regional PODs and clinics. Superintendent encouraged everyone who is eligible to take advantage of these growing opportunities and to be mindful that when scheduling an appointment, a vaccine is being set aside specifically for the appointment. Every appointment that's not kept is a vaccine that could have gone to someone else. He acknowledged that this week is National School Social Worker Week and March is Social Work Month. He thanked all SAUSD social workers and social workers within the community who play a vital role in connecting schools with community and for supporting the social emotional wellbeing of families, students, and staff. School Social Workers have worked with families and schools throughout the pandemic to ensure students reach their full academic and personal potential. He also announced that this week is also National School Breakfast Week. He thanked the Nutrition Services staff, who recently distributed 5 million meals since the beginning of school. In addition to Ms. Amezcua, other Board members have also been active in making those comments behind the scenes to ensure our community members are vaccinated. Lastly, Superintendent shared that he was contacted by the City Manager with a desire to reinstate the joint Board meetings with city council. He asked Board members if they wanted to participate. Dr. Rodriguez asked for it to be added to the next Board agenda to formally take action.

PUBLIC PRESENTATIONS

Dr. Rodriguez asked Ms. Quiroz if there was anyone wishing to address the Board. Public speakers addressed Read Across America, distance learning vs. in person instruction, reopening of schools, teaching students with moderate to severe to profound disabilities, summer school, and joint meetings with city of Santa Ana.

BOARD REPORTS

Dr. Alvarez gave a shout out to all School Social Workers. He commented on the reinstatement of the meetings with the City Council and said they should go beyond the quarterly meetings. He acknowledged Boca de Oro, thanked public speakers, and thanked staff that has supported with vaccinations, meal distribution, and learning labs. Dr. Alvarez reminded everyone to practice COVID protocols wearing masks and social distancing.

Ms. Amezcua thanked the staff who have been working with community partners on vaccines and also thanked Dr. Lopez-Guerra and Michelle Dominguez who have been working Monday through Sunday to get everyone vaccinated. She shared that Monday there was a meeting with City elected officials, Santa Ana College, Representative Lou Correa, Senator Daly, Senator Umnberg, Dr. Mijares, and Christine Ridge on how to get more vaccines to Santa Ana staff in order to resume school safely. Ms. Amezcua also thanked Sal Tinajero, Zeke Hernandez, Mr. Palacio, Representatives from State and Federal level, OC Labor Federation, CWA, Barbara Pearson, Cecilia Lopez, and Kenny Williams. Ms. Amezcua asked the Superintendent to continue to address the number of spectators allowed at sporting events as numbers continue to decrease. She also asked for a B2B report on whether student's temperatures are being taken and who is responsible for doing it, on whether the PPE equipment being purchased has expiration dates, and the schedule of district staff who is working on and off site. Ms. Amezcua asked if Sepulveda/McFadden is being renamed? She asked that a conversation be held with the Board first and to inform families who attend those schools. She asked if parents have been given information on graduation. Ms. Amezcua thanked Nutrition services staff for the 5 million meals served.

Mr. Palacio thanked staff for allowing him to participate in Read Across America. He acknowledged the work with Downtown Santa Ana and all the Arts and Non-Profit groups and highlighted Boca de Oro. He also acknowledged Ms. Amezcua's leadership in involving legislators, congressmen, local elected officials, and labor groups in engaging with Dr. Mijares to gain access to vaccines. Mr. Palacio asked if lists are being kept of employees that have received vaccinations. He stated that a system needs to be created to see how many employees have already received the vaccine and what stage they are in. He suggested that employees be surveyed. He also stated that staff needs to take the extra step to help the employees that don't have access to computers or ability to sign up for testing. He asked staff to communicate with Board on what the plans and options there are for reopening. He added he is excited for the opportunities of athletes who are participating in competitive sports and looks forward to the expansion of other sports and programs.

Ms. Torres thanked District staff for their presentations and all classified and certificated staff that have reached the one-year mark of the COVID pandemic. She asked everyone to be as careful as possible with restaurants and Disneyland are opening. She stated that there is no other reason other than safety to keep students in distance learning depending on the reports given at the next Board meeting. Ms. Torres encouraged teachers and staff to let students know about the expanded eligibility for vaccines of groups under 1B. Ms. Torres thanked student Aaliyah España Molina for her public comment on an issue she thought was important, which was shifting attention away from Dr. Seuss' books.

Dr. Rodriguez acknowledged and thanked all the social workers especially Dr. Llamas and Dr. Alvarez for their commitment to healing District communities and connecting them. He also thanked Dr. Lupe Gomez for inviting him to read to her school. He commented on the Dr. Seuss' books. Dr. Rodriguez also thanked Robyn McNair for inviting him to participate in a panel for Boca de Oro. He added that he wants to make sure events like these really create a portal to have critical conversations to what it means to be part of the city. He stated that the pressure and importance of reopening of schools in ways that are going to be helpful to everyone. He stated that he as other Board members are getting calls from parents, some who want schools open now, some who don't, calls from teachers, and emails from staff. Agrees with Mr. Palacio in surveys, in knowledge in what constituents, parents, students, teachers, and classified are feeling and thinking along with general policies to make the best decision possible. He stated that the school reopen is the short term urgent issue that needs to be in focus and the second is to complete Board priorities that are linked to the LCAP and budget. Dr. Rodriguez asked Superintendent to provide an update on how they are proceeding to complete the task of identifying Board priorities and how they are linked to the LCAP and budget.

Dr. Rodriguez closed the meeting in memory of an SAUSD student that lost his life last week.

The Regular Board meeting recessed at 10:33 p.m. to closed session to consider negotiations.

The Regular Board meeting reconvened at 11:02 p.m.

WHEREAS, the Santa Ana Unified School District ("District") desires to make a Mesh Area Network (WAN) available for use by its students and teachers in connection with the District's educational programs ("District Network"); and

WHEREAS, as set forth in Public Contract Code Section 20118.2 ("Section 20118.2"), the California Legislature has determined that, in light of the highly specialized and unique nature of technology, telecommunications, related equipment, software and services, it is in the public's best interests to allow school districts, when awarding contracts for computers and other technology as specified in Section 20118.2, to consider factors other than just price; and

WHEREAS, Section 20118.2 establishes a process for procuring technology that includes issuance of a request for proposals ("RFP"), publication of a notice of the RFP, evaluation of responses, and award of the contract to the company whose proposal satisfies the requirements of the RFP and will be the most advantageous to the school district with price and all other factors considered; and

WHEREAS, on or about December 30, 2020, the District approved and issued an RFP for Mesh Wide Area Network (WAN) Services as a basis for procuring a WAN service provider and related services ("Mesh Wide Area Network (WAN) Services RFP") and, on December 30, 2020, and January 6, 2021, notice of the Mesh Wide Area Network (WAN) Services RFP was published in the Orange County Register; and

WHEREAS, on January 29, 2021, the District received a response to the Mesh Wide Area Network (WAN) Services RFP from only one company, AT&T Corp. ("AT&T"); and

WHEREAS, based on the Mesh Wide Area Network (WAN) Services RFP having been received by 86 different companies in the relevant industry, 18 of which registered with the District as potential vendors, the District subsequently determined and found, in accordance with Section 20118.2, that the District had made every effort to generate the maximum feasible number of proposals from qualified sources; and

WHEREAS, a panel consisting of three District representatives duly evaluated the response to the Mesh Wide Area Network (WAN) Services RFP submitted by AT&T, based on all significant evaluation factors set forth in, and using the procedures for technical evaluation set forth in, the Mesh Wide Area Network (WAN) Services RFP; and

WHEREAS, the evaluation factors mentioned in the preceding recital included: (i) E-rate eligible recurring and one-time circuit costs, (ii) Technical Qualifications: Ability to Support the RFP Requirements, Service Reliability and dedicated infrastructure, and firms' qualifications (iii) a Complete proposal submission, (iv) Implementation Timeline/Ability to deliver service, as requested, within the desired timeframe, (v) Proposed contract terms and conditions: Exceptions requested, Review of included Service Level Agreement (SLA) and Master Service Agreement (MSA), (vi) E-rate ineligible recurring or one-time costs, and (vii) Provider references; and

WHEREAS, upon evaluating all responses to Mesh Wide Area Network (WAN) Services RFP, the review panel determined that AT&T's proposal met all evaluation standards and achieved a sufficient number of total points, and that it will be most advantageous to the District, and in the District's best interests, to award the contract for the Mesh Wide Area Network (WAN) Services and related services to AT&T; and

WHEREAS, the District and AT&T have set forth the terms and conditions to implement the proposal by AT&T in that certain agreement by and between the District and AT&T that is entitled "ATTACHMENT TO CALNET Authorization to Order ("Agreement") FOR SERVICES AND/OR PRODUCTS SUBJECT TO E-rate FUNDING" and "CALNET AUTHORIZATION TO ORDER (ATO)" (together, the "Service Agreement"), and, prior to consideration of this Resolution by the Board of Education of the Santa Ana unified School District ("Board of Education"), the District provided a copy of the Service Agreement to the Board of Education for its review and consideration; and

WHEREAS, the "Pricing Structure" attached to the Service Agreement identifies the service, type, and other specifications for the Mesh Wide Area Network Service, and provides that, without need for further action by the Board of Education; and

NOW, THEREFORE, the Board of Education does hereby find, order, and resolve as follows:

The Board of Education hereby authorizes and directs the Superintendent of the District ("Superintendent"), the Assistant Superintendent of Business Services for the District ("Assistant Superintendent"), the Director of Purchasing and Stores for the District ("Director"), and/or their designee, to promptly sign and deliver the Authorization to Order (ATO) and Service Agreement separately.

<u>Section 5</u>. Prior to execution of the Authorization to Order (ATO) and Service Agreement, the Superintendent, Assistant Superintendent, Director, and/or their designee, in consultation with District legal counsel, may make such non-substantive revisions to those documents as may be advisable and/or necessary.

The Board of Education hereby authorizes and directs the Superintendent, 106 the Assistant Superintendent, Director, and/or their designee, to take any 107 and all such actions, execute and deliver such other documents, and expend 108 such funds, as are necessary to implement the intent of this Resolution.

SCOPE:

The Governing Board recognizes the positive benefits of physical activity on student health and academic achievement. The district shall provide all students the opportunity to be physically active on a regular basis through high-quality physical education instruction and may provide additional opportunities for physical activity throughout the school day. The district's physical education and activity programs shall support the district's coordinated student wellness program and encourage students' lifelong fitness. (cf. 5030 - Student Wellness)

POLICY:

The overall course of study for grades 9-12 shall include the effects of physical activity upon dynamic health, the mechanics of body movement, aquatics, gymnastics and tumbling, individual and dual sports, rhythms and dance, team sports, and combatives. (Education Code 33352; 5 CCR 10060)

The Board shall approve the courses in grades 9-12 for which physical education credit may be granted. (cf. 6146.1 – Graduation Requirements – Senior High School) (cf. 6146.11 - Alternative Credits Toward Graduation)

The district's physical education program shall engage students in moderate to vigorous physical activity, as defined in the accompanying administrative regulation, for at least 50 percent of class or session time. The Superintendent or designee shall develop strategies to monitor the amount of moderate to vigorous physical activity that takes place in the physical education instructional program.

Physical education classes shall be conducted in the coeducational, inclusive manner prescribed by law. The district shall provide instruction in physical education that provides equal access and equal opportunities for participation for all students in grades 1-12 regardless of gender, gender expression, sexual orientation, and mental or physical disability. (Education Code 220, 221.5, 33352; 5 CCR 4900, 4930, 4931, 4940, 4960; 34 CFR 106.33, 106.34, 300.108)

Students with disabilities shall be provided instruction in physical education in accordance with their Individualized Education Program (IEP) or Section 504 accommodation plan. (cf. 6159 - Individualized Education Program) (cf. 6164.6 - Identification and Education Under Section 504)

During air pollution episodes, extreme weather, or other inclement conditions, physical education staff shall make appropriate adjustments to the program or shall seek alternative indoor space to enable students to participate in active physical education. (cf. 3514 - Environmental Safety) (cf. 5141.7 - Sun Safety)

The Superintendent or designee shall develop strategies to supplement physical education instruction with additional opportunities for students to be physically active before, during, and after the school day. (cf. 1330.1 - Joint Use Agreements) (cf. 5142.2 - Safe Routes to School Program) (cf. 5148 - Child Care and Development Program) (cf. 5148.2 - Before/After School Programs) (cf. 6145 - Extracurricular and Co-curricular Activities

Staffing

Physical education instruction shall be delivered by appropriately credentialed teachers who may be assisted by instructional aides, paraprofessionals, and/or volunteers. (cf. 4112.2 - Certification) (cf. 1240 - Volunteer Assistance) (cf. 4112.21 - Interns) (cf. 4113 - Assignment) (cf. 4222 - Teacher Aides/Paraprofessionals)



The district shall provide physical education teachers with continuing professional development, including classroom management and instructional strategies designed to keep students engaged and active and to enhance the quality of physical education instruction and assessment. (cf. 4131 - Staff Development) (cf. 5121 - Grades/Evaluation of Student Achievement)

Physical Fitness Testing

The Superintendent or designee shall annually administer the physical fitness test designated by the State Board of Education to students in grades 5, 7, and 9. (Education Code 60800; 5 CCR 1041)

Temporary Exemptions

The governing board of the Santa Ana Unified School District may grant a temporary exemption from physical education under either of the following conditions: (Education Code 51241)

1. The student is ill or injured and a modified program to meet his/her needs cannot be provided.

- 2. The student is enrolled for one-half time or less.
- Two-Year Exemptions

With the student's consent, the governing board of the Santa Ana Unified School District may exempt a student from physical education courses for any two years during grades 10-12 provided that the student has satisfactorily met at least five of the six standards of the state's Physical Fitness Test in grade 9. (Education Code 51241)

Upon request by students and/or their parents/guardians, the Superintendent or designee may administer the Physical Fitness Test to students in grades 10-12 who need to pass the test in order to qualify for a two-year exemption from physical education courses.

Students in grades 10-12 who have been granted a two-year exemption shall be offered a variety of elective physical education courses of not less than 400 minutes each 10 school days. (Education Code 51222)

Such students shall not be permitted to attend fewer total hours of courses and classes than they would have attended if enrolled in a physical education course. (Education Code 51241) (cf. 6112 - School Day)

Permanent Exemptions

The governing board of the Santa Ana Unified School District may grant a permanent exemption from physical education to an individual student under any of the following conditions: (Education Code 51241)

1. The student is age 16 years or older and has been enrolled in grade 10 for one or more academic years.

2. The student is enrolled as a postgraduate student.

3. The student is enrolled in a juvenile home, ranch, camp, or forestry camp school with scheduled recreation and exercise.



Other Exemptions

The governing board of the Santa Ana Unified School District may grant an exemption from physical education under the following special circumstances:

1. The student in grades 10-12 is excused for up to 24 clock hours in order to participate in automobile driver training. However, any such student shall attend a minimum of 7,000 minutes of physical education instruction during the school year. (Education Code 51222) (Education Code 51222)

2. When the student is in any of grades 10-12, attends a regional occupational center or program, and, because of the travel time involved, would experience hardship to attend physical education courses. Any such student shall have a minimum school day of 180 minutes. (Education Code 52316) (cf. 6178.2 - Regional Occupational Center/Program)

3. The student is a four-year or a senior in high school and is engaged in a regular school-sponsored interscholastic athletic program. carried on wholly or partially after regular school hours. (Education Code 51242) (cf. 6145.2 - Athletic Competition)

Program Evaluation

The Superintendent or designee shall annually report to the Board the results of the state physical fitness testing for each school and applicable grade level. He/she shall also report to the Board regarding the number of instructional minutes offered in physical education for each grade level, the number of two- year and permanent exemptions granted pursuant to Education Code 51241, and any other data agreed upon by the Board and the Superintendent or designee to evaluate program quality and the effectiveness of the district's program in meeting goals for physical activity.
