SUPERINTENDENT'S REPORT

Superintendent informed the public that the District is beginning to develop a re-entry plan for next school year and have formed a committee with representatives from all different levels. A survey has been developed and sent to teachers and families to get feedback on their preferences and what the families' needs are. Once all the information is collected, staff will use it in addition to the information on the design developed by the implementation team to bring more clarity to what the Fall semester will look like. It will most likely have a hybrid look, with a combination of remote learning along with face-to-face learning with social distancing in mind. Staff is also trying to get clarity on whether the state will provide personal protective gear or if the District will be providing these resources. There are a number of families as well as employees that fall under high risk category. Staff is working on meeting those needs and the needs of students. Superintendent also Congratulated the Class of 2020. He thanked teachers and classified staff during the transition during this crisis. Everyone has been trying to meet the needs of the students and the community. Mr. Almendarez stated that as soon as there is clarification for the fall session, he will push it out to all the families.

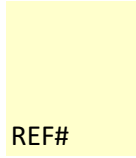


