SANTA ANA BOARD OF EDUCATION

May 9, 2006

CALL TO ORDER

The meeting was called to order at 4:30 p.m. by Board President Yamagata-Noji. Other members in attendance were Mr. Richardson, Mrs. Avila, and Mr. Palacio. Mr. Tinajero arrived at 5:15 p.m.

Cabinet members present were Dr. Mijares, Ms. Russo, and Dr. Stainer.

MEETING RECESSED AND RECONVENED

At 4:30 p.m., the Regular meeting was recessed to Closed Session to consider legal matters, personnel matters, special education contracts, and student discipline issues.

The Regular meeting reconvened at 5:30 p.m.

PLEDGE OF ALLEGIANCE

The meeting opened with the Pledge of Allegiance led by Mr. Palacio.

SUPERINTENDENT'S REPORT

The Superintendent called to the attention of those present the beautiful artwork posted in the Board Room contributed by the students and teachers at Madison Elementary and MacArthur Fundamental Schools.

On Monday, May 1st, the country experienced a day of immigration reform. A unified message was sent through various media asking students to remain in school. The SAUSD worked diligently with community organizations to make this happen. There was a five-percent student absentee report on that day which is typical for a Monday or Friday, with no incidents or disturbances reported. Dr. Mijares thanked parents, students, staff, administrators, City of Santa Ana, and the community of Santa Ana for their support and for encouraging children to stay in school.

Dr. Mijares thanked the Orange County Hispanic Chamber of Commerce for their support to education. On Saturday, April 29th, the Hispanic Chamber of Commerce recognized the work the SAUSD has done to educate our youth. Dr. Mijares was recognized for his many contributions to the students of Santa Ana and his leadership of this organization. Channel 31 shared highlights of the event.

On Friday, April 28th, MacArthur Fundamental had its annual History Faire, as the engaging culmination of their seventh grade World History curriculum. Channel 31 was there that day to capture the event.

Dr. Mijares introduced to the Board and Community the newly-elected President of the District English Learner Advisory Committee, Mr. Jose Pulido. He was accompanied by Mrs. Victoria Zaragoza, President of the District Advisory Committee. Mr. Pulido remarked that he looks forward to working with parents, students, and staff at the SAUSD.

May is the month to celebrate Education, and has a conglomeration of special days. On the agenda, there are three separate Board Resolutions for approval. Congratulations to SAUSD school nurses for May 10th, School Nurses Day; SAUSD teachers for May 10th, Day of the Teacher and Support Staff; and SAUSD classified employees, for their upcoming Classified Employees Week, May 21st through the 27th.

On April 26, 2006, the Central County Regional Occupational Program celebrated *Sowing the Seeds of Greatness* and recognized the hard work, dedication, and overall greatness of students who were nominated for their strong work ethic, their inspirational qualities, and their commitment to career success. As you know, some of our students participate in ROP, and 10 of 340 students highlighted were from SAUSD, representing Santa Ana, Century and Saddleback High Schools.

Sixty-two Diamond Elementary students from the Nurture, Enrich, Support and Teach (NEST) Program, were presented with bicycles on Saturday, April 29, after they volunteered to clean up and beautify their school. Sheriff Mike Carona was on hand to deliver the bikes to students. Congratulations to the NEST coordinator, Craig Macias, and Principal Deanna Pelaski.

Championship Soccer Coach Mel Silva, from Saddleback High School, was recently interviewed by KMEX due to being the National Spokesperson for the Walt Disney movie *Goal, The Dream Begins*. It's a story about a Hispanic boy who overcomes the odds through his passion and dedication to the game of soccer. Coach Silva is a picture-perfect spokesperson for this inspiring film.

The SAUSD is extending an invitation to the Santa Ana community to participate in the annual *Insight to Santa Ana Schools*, on Thursday, May 11th. The touring group will gather at Santa Ana High School at 8:30 a.m. and continue to Godinez Fundamental, Century High School (to take a sneak peak of their Animation Program and their eBusiness Academy), and finally return to Santa Ana High's Kubba Gardens for a lunch gathering. The annual *Arts on the Lawn*, which portrays students' visual and performing arts will be on display.

Carr Intermediate will be holding its 50th Anniversary Celebration on Saturday, May 20th, at the school's athletic field, from 11:00 a.m.-7:00 p.m. They will have two stages with live bands and dance performances, as well as fun activities for students, karate demonstrations, reptiles from Rain Forest Café, and much more. The admission is free, and the public is welcome to attend and join in this celebration of half-a-century of education.

Grant Elementary is featured on the front page of SAUSD's Newspaper, *Above the Mean & Beyond*, for their successful participation in the "100% Campaign," which is funded by a private grant from St. Joseph Hospital, St. Jude Medical Center, and Mission Hospital to provide insurance to all children in Orange County, one school at a time. We expect that this program will help reduce the number of student absences due to illness.

2.0 AUTHORIZATION TO AWARD A CONTRACT FOR CONSTRUCTION OF VALLEY HIGH SCHOOL MODERNIZATION PROJECT

Mr. Hills, Manager of Construction, provided clarification concerning overall project construction contingencies. He then outlined each bid package.

It was moved by Mr. Richardson, seconded by Mr. Tinajero, and carried 5-0, to award contracts to the above-listed apparent lowest responsible bidders for a total amount of \$15,063,772.86 for the construction of Valley High School modernization project.

3.0 APPROVAL OF INDEPENDENT FINANCIAL AND PERFORMANCE AUDIT REPORT OF MEASURE C BOND FUNDS FOR FISCAL YEARS 2003-04 AND 2004-05

It was moved by Mr. Tinajero, seconded by Dr. Yamagata-Noji, and carried 4-0, Mr. Richardson not present, to approve the Independent Financial and Performance Audit report of Measure C Bond funds for fiscal years 2003-04 and 2004-05. Mr. Palacio asked for an audit of Tustin Settlement Funds. Administration was asked to look into the feasibility of the request in regards to the overall budget.

4.0 SECONDARY HISTORY/SOCIAL SCIENCE TEXTBOOKS AND SUPPLEMENTAL MATERIALS RECOMMENDED FOR 28-DAY REVIEW

5.0 APPROVAL OF SUBMISSION OF LANGUAGE ARTS AND MATHEMATICS PROFESSIONAL DEVELOPMENT PROGRAM AB 466 APPLICATION TO CALIFORNIA DEPARTMENT OF EDUCATION

It was moved by Mr. Palacio, seconded by Mr. Tinajero, and carried 4-0, Mr. Richardson not present to approve submission of the Language Arts and Mathematics Professional development program AB 466 application to the California Department of Education for the 2005-06 school year.

6.0 APPROVAL OF LAYOFF OF CERTIFICATED EMPLOYEES

Dr. Mijares stated that due to the reduction of elementary teaching positions supported by declining enrollment and budgetary issues, it is necessary to lay off employees based upon seniority and credentialing.

It was moved by Mr. Richardson, seconded by Dr. Yamagata-Noji, and carried 3-1, Mr. Tinajero absent and Mr. Palacio dissenting, to approve the Administrative Law Judge recommendation decision supporting the layoff of 86 certificated employees for the 2006-07 school year.

7.0 ADOPTION OF SANTA ANA UNIFIED SCHOOL DISTRICT REOPENING BARGAINING PROPOSAL TO CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION (CSEA) FOR 2004-07 AND CALL FOR PUBLIC HEARING

It was moved by Mr. Palacio, seconded by Dr. Yamagata-Noji, and carried a 5-0, to adopt the District reopening bargaining proposal to CSEA and call for a public hearing on the Board of Education initial bargaining proposal to California School Employees Association for the 2004-07 school years.

8.0 PERSONNEL ACTION

It was moved by Mr. Palacio, seconded by Mr. Tinajero, and carried 5-0, to approve the personnel calendar in its entirety.

9.0 BOARD REPORTS/ACTIVITIES

Mrs. Avila:

- ❖ Commended SAUSD for informing students and parents about the importance of staying in school as they enter the end of the year testing period.
- ❖ A letter in connection to the May 1 protest from a parent was circulated at a school. As Mrs. Avila read portions of the letter,

she asked that the following comments be stated for the record: According to the letter, students have the right to skip school to protest then return to school and disrupt the normal flow of teaching to receive personalized attention from the teacher to review the prior days' lesson. The parent believes the student's right to protest overrides the right of his classmates to receive academic training. The letter was extremely flawed and hopes the principal was knowledgeable of the California law that requires accountability of the truant student.

Mr. Richardson:

- ❖ Commended staff and the community for their conduct during the May 1st demonstration in the Civic Center area. He appreciated the open communication between Board, Superintendent, SAPD, Chief Walters, City officials and others who contributed. He thanked those responsible for having no students walk out from any Santa Ana schools on that day.

Mr. Tinajero:

- ❖ Echoed Mr. Richardson. He also conveyed appreciation to staff and students for having no walkouts on May 1st. He believes that students should not be punished for not attending school, but should attend Saturday school as a make-up day.

Mr. Palacio:

- ❖ Echoed Mr. Richardson and Mr. Tinajero.
- ❖ Responded to Mrs. Avila's comment. He said that the District cannot treat any student differently than another. He then clarified the Education Code.

Dr. Yamagata-Noji:

- ❖ Attended the Hispanic Chamber of Commerce awards ceremony was excellent. Superintendent Mijares and Ms. Medrano were recipients of awards.
- ❖ Attended the Valley High School musical performance *Once Upon A Mattress*, running nightly, on May 4, 5, & 6 at 7:30 p.m. It was a outstanding production! Would like a film clip at the next Board meeting or have a couple of students sing at a Board meeting.
- ❖ Invited all to attend the "Insight to the Santa Ana Schools Tour," beginning at Santa Ana High School from 8:30 a.m. to 12 noon.
