REGULAR MEETING  
SANTA ANA BOARD OF EDUCATION

July 24, 2012

CALL TO ORDER

The meeting was called to order at 5:00 p.m. by President Richardson. Other members in attendance were Mr. Palacio and Mr. Reyna.

Cabinet members present were Dr. Meléndez de Santa Ana, Dr. Olsky, Mr. Bishop, Mr. Lopez, Mr. Mendez, Ms. Lohnes, Mr. Dixon, Ms. Miller, and Mr. Hammitt.

CLOSED SESSION PRESENTATIONS

Mr. Richardson asked those wishing to address the Board in matters pertaining to Closed Session to step to the lectern.

There were no individuals wishing to address the Board on matters of Closed Session.

RECESS TO CLOSED SESSION

The Regular Board meeting was immediately recessed to consider legal issues, negotiations, and personnel matters. Dr. Yamagata-Noji arrived during Closed Session.

RECONVENE OPEN MEETING

The Regular Board meeting reconvened at 6:20 p.m. Mr. Hernández arrived during Open Session.

PLEDGE OF ALLEGIANCE

The meeting was opened with the Pledge of Allegiance led by Mr. Reyna.

**SUPERINTENDENT'S REPORT**

Dr. Meléndez greeted all present.

Dr. Meléndez was pleased to announce that through the District's collaborative partnership with the Pacific Symphony Orchestra and THINK Together; students from Diamond, Harvey, and King elementary schools have had an incredible opportunity to receive violin instruction provided by musicians of the Pacific Symphony. The pilot project - Santa Ana Summer Strings - is the culmination of several years of planning among all partners, and the culminating event to showcase this successful collaboration is July 29 at the Symphony in the Cities Concert at The Great Park. Students are scheduled to perform at 5:30 p.m. and 6:10 p.m. Dr. Meléndez gave a special thanks to the Pacific Symphony Orchestra and THINK Together for their generous contribution, and Assistant Superintendent of Elementary Division, Herman Mendez and all of those who have worked closely with Mr. Mendez to make this program such a huge success.

Dr. Meléndez mentioned that over the last several weeks, the District leadership team worked with curriculum specialists, CLAS teachers, and the Common Core Task Force, which consists of approximately 30 site administrators, to develop Common Core units. This past week, the units were introduced to students during the Summer Extended Learning program. Students were building knowledge through informational texts, grounding their thinking with evidence from the text, and engaging in collaborative conversations. Tonight, you will hear more about the Common Core implementation during a presentation.

Dr. Meléndez gave a brief update on many of the improvements that have occurred at schools. This summer, there have been major renovations at 25 sites. Thanks to the hard work of Assistant Superintendent of Facilities and Governmental Relations, Joe Dixon, many projects have been completed and nearing completion in preparation of the new school year. Dr. Meléndez mentioned that since 2009, 346 new classrooms have been built, 225 classrooms have been renovated, and 429 portables have been removed.

Dr. Meléndez concluded her remarks by acknowledging the Early Start Program, located at Mitchell Child Development Center. Early Start has been recognized by the State as a model program. The Mitchell Early Start Program serves children birth to 36 months who have identified needs, as well as some mainstreamed children from the general community. As a model program, the Mitchell Child Development Center Early Start Program will be a visitation site for the SEEDS project, which stands for "Supporting Early Education Delivery Systems." SEEDS is a project of the California Department of Education, Special Education division that offers training and technical assistance to administration, staff, and families involved in early childhood special education programs throughout California.

Dr. Olsky presented to the Board an introduction and overview of the Common Core State Standards and administration's plan to implement the major phases and activities of the initial implementation for the 2012-13 school year.

Board President Richardson asked Joe Dixon, Assistant Superintendent, Facilities and Governmental Relations, to step to the lectern. Mr. Dixon provided the Board of Education a facilities update and report of Measure G activities.






