Tuesday, May 14, 2024

1. CALL TO ORDER

Board Vice President Alvarez called the meeting to order at 5:03 p.m.

Other members present were Mr. Bustos, Ms. Brazer Aceves, and Dr. Rodriguez with Ms. Torres absent.

Dr. Alvarez announced the closed session agenda items as follows: Conference with Labor Negotiator, Personnel Matters, Existing Litigation, Anticipated Litigation, and Conference with Real Property Negotiator. She asked if there was anyone wishing to address the Board related to closed session items. There was no one wishing to address the Board related to closed session items.

5. LAND ACKNOWLEDGEMENT

Dr. Alvarez read out the land acknowledgement statement as follows: I want to recognize that our District and school campuses are located in the Village of Pasbenga. I want to acknowledge that this land we refer to as Orange County, is the unceded and traditional lands of the Gabrieleno Tongva Nation, and the Juaneño Band of Mission Indians Acjachemen Nation. These lands were taken through a process of colonization, physical, and cultural genocide. I want to pay my respect to elders, both past and present, as well as the Tongva and Acjachemen youth who have attended and that are currently attending our schools in neighboring districts.

10. SUPERINTENDENT'S REPORT

Superintendent Almendarez shared that May is the recognition month for various school employee groups. Last week was Teacher and Certificated Support Staff Appreciation Week. He thanked all teachers for their dedication and enthusiasm in educating our students, providing both academic and social-emotional support. Teaching is more than a career for them; it is a passion. He also thanked certificated support staff for their invaluable contributions, including counseling, speech and language services, and administrative leadership, which create a supportive environment essential for student growth. The Superintendent congratulated Cassandra Cabrera, a science teacher at Mendez Fundamental Intermediate School, for being named Orange County Teacher of the Year. Ms. Cabrera, a dedicated educator for eleven years, has introduced innovative CTE programs. She is now a contender for California Teacher of the Year, reflecting her exceptional impact in education. Mr. Almendarez also celebrated School Principals Day earlier this month, acknowledging principals' leadership and dedication in fostering productive learning environments. He encouraged everyone to thank a principal they know. May 3rd was School Lunch Hero Day, recognizing the professionals who prepare meals for students. These staff members play a vital role in linking nutrition to academic performance. The Superintendent thanked the Nutrition Services Team for their positive impact.

Mr. Almendarez shared that from May 6th to May 12th, SAUSD observed National School Nurses Week. School nurses and LVNs serve as a safety net for students, identifying health issues and promoting good hygiene, vaccination compliance, and nutrition education. The Superintendent thanked all school nurses. He added that National Police Week was from May 12th to 18th and recognized Santa Ana School Police Officers for their dedication to student and community safety. He shared that they also support awareness campaigns on preventing drug and alcohol use, bullying, and vaping and thanked our School Police Department.

Superintendent Almendarez also shared that Classified School Employee Week was from May 19th to 25th, which celebrates classified employees' essential roles. They ensure students receive nutritious meals, maintain campus health and safety, support instruction, and facilitate community engagement. The Superintendent thanked all classified employees. 

CONDEMNING SEGREGATION IN SCHOOLS

WHEREAS, the Santa Ana Unified School District is committed to promoting equity, diversity, and inclusion of all students, teachers, staff, and their families; and

WHEREAS, in March 1945, the Mendez family and four other Mexican-American families filed suit against the Westminster, Garden Grove, Santa Ana, and El Modena school districts, alleging that the districts conspired with each other to prevent students of Mexican or Latin descent from attending schools their white peers attended, solely for the reason that they are of Mexican or Latin descent;¹ and

WHEREAS, the legacy of the five Mexican-American families who fought for the desegregation of Orange County schools in *Mendez v. Westminster* (9th Cir. 1946) 64 F.Supp. 544, reminds us of the importance of racial equity and justice in our schools; and

WHEREAS, on April 14, 1947, the United States Court of Appeals for the Ninth Circuit held in *Westminster School Dist. of Orange County, et al. v. Mendez* (9th Cir. 1947) 161 F.2d 774, that segregated schools violated the equal protection clause of the Fourteenth Amendment of the United States Constitution; and

WHEREAS, on May 17, 1954, the United States Supreme Court unanimously held in *Brown v. Board of Education of Topeka* (1954) 347 U.S. 483, that the “separate but equal” standards of racial segregation were unconstitutional, and paved the way for school desegregation throughout the United States; and

32 **WHEREAS**, the Governing Board recognizes that the Santa Ana Unified School District must
33 acknowledge and confront its involvement in the segregation of Mexican-American students in Orange
34 County prior to the case of *Mendez v. Westminster*, which forced students to attend inferior schools based
35 on student surnames; and

36
37 **WHEREAS**, the Governing Board recognizes that racially and socioeconomically diverse schools
38 offer students important social-emotional benefits by exposing them to peers of different backgrounds,
39 and that increased tolerance and cross-cultural dialogue that result from these interactions are beneficial
40 for society.²

41
42 **WHEREAS**, segregation is harmful to students, not only to their education, but also to their
43 psyche because segregation “by its very nature, is a reminder constantly of inferiority, of not being wanted,
44 of not being a party of the community.”³

45
46 **WHEREAS**, it is the responsibility of school personnel and adults in the community to create
47 spaces that allow all students, and particularly marginalized students, to engage in school to their fullest
48 potential; and

49
50 **WHEREAS**, segregation continues to be an issue in United States public schools today. As of the
51 2018-2019 school year, one in six public students attended schools where over 90 percent of their peers
52 had the same racial background;⁴ and

53
54 **WHEREAS**, the Governing Board will continue to take a stand against segregation and
55 discrimination in all forms, and apologizes to all students of the District who were subject to such practices
56 in the past; and

57
58 **WHEREAS**, our District is committed to evaluating and dismantling practices and policies that
59 lead to segregation of students according to race and socioeconomic status; and


