BACKGROUND INFORMATION:

The purpose of this agenda item is for the Board of Education to discuss their Priorities for the 2014-15 school year.

RATIONALE:

This item allows for discussion as it is imperative that the District develop and implement Board priorities for the purpose of identifying critical instructional, financial, and operational needs of the District.

The Board discussion will occur in two basic segments: 1) some of the individual interests of Board members, and 2) the collective interests of the Board for the coming year, particularly in the area of program options of LCFF and LCAP.

In the initial segment, each Board member will have the opportunity to discuss his/her individual interest regarding:

- 1. What do you believe are the most pressing issues in the SAUSD?
- 2. As a SAUSD Board member, what do you see as your highest priority to accomplish or what do you want as a legacy for your time as a Board member?
- 3. In your view, what are the greatest successes in the SAUSD?

In a broader discussion, we are all aware of LCFF and LCAP and the need to create a response to the specific needs of our students and their learning needs. From a policy perspective, what are the parameters and priorities of the Board for the coming year? At this time, these priorities cannot be specific, cost-analyzed, or mandated/directed as we are missing detailed information and the community input and dialogue that is a critical part of the LCFF/LCAP process. After this initial discussion, we will move to a community input process to understand the community perspective. That information will be melded with the "Board priority" information for a Spring presentation to the Board that will result in the LCFF/LCAP budget for 2014-15.
