School Description

Thomas A. Edison Elementary School (Edison) is located on Orange Avenue, east of South Main Street and north of East Warner Avenue.

Edison is a completely renovated and modernized facility. All portable classrooms have been replaced by two, two-story buildings containing 24 classrooms. The original buildings built in 1937 and 1951 have also been modernized. A staff parking lot has been added as well as new landscaping throughout the entire campus. All classrooms have a complete technology package that include Smart Boards/Clevertouch Interactive Boards, LCD projectors, Avermedia projectors, chromebooks, and ipads for students and teachers. The school also has three computer labs and one-to-one chrome books in grade TK-5. Edison is well equipped to prepare our students for college and career in the 21st Century.

Edison incorporates 8 Keys of Excellence to increase student motivation by creating a positive school climate. By applying the 8 keys of success daily, students develop the skills needed for success in their academic and personal lives along with the development of leadership characteristics. Our goal is to help all students find their own leadership abilities that they can apply throughout their lives. These leadership skills will prepare our students to communicate with others, work collaboratively, and to be proactive and always have a plan. Students are given many opportunities in and out of the classroom to apply and practice their leadership skills throughout the day. Along with the 8 Keys of Excellence, we incorporate Positive Behavioral Interventions and Supports (PBIS). This is a decision making framework that guides selection, integration, and implementation of the best evidence-based academic and behavioral practices for improving important academic and behavior outcomes for all students. Edison received Platinum status in the implementation of the program goals. Edison embeds the AVID framework and strategies to accelerate learning growth and ensure all students are college ready. A SAUSD District Run after-school program (Engaged 360) is available for Edison's students in grades K-5 between 2:05 p.m. and 6:00 p.m. A portion of this time is devoted to homework completion and tutoring. The remaining time is spent engaging students in fun, organized activities and structured enrichment programs (music, dance, art, physical activity, etc.). Edison also offers a Head Start preschool program on campus. Preschool students are prepared with early literacy skills so they will enter kindergarten ready to learn. Two full day and two half day preschool classes are offered to families in the SAUSD community.

District Profile

Santa Ana Unified School District (SAUSD) is the eleventh largest district in the state, currently serving nearly 45,576 students in grades K-12, residing in the city of Santa Ana. As of 2019-20, SAUSD operates 36 elementary schools, 8 intermediate schools, 7 high schools, 4 educational options-secondary schools, and 1 dependent charter school. The student population is comprised of 81% enrolled in the Free or Reduced Price Meal program, 38% qualifying for English language learner support, and approximately 13% receiving special education services. Our district's schools have received California Distinguished Schools, National Blue Ribbon Schools, California Model School, Title I Academic Achieving Schools, and Governor's Higher Expectations awards in honor of their outstanding programs. In addition, 20 schools have received the Golden Bell Award since 1990.

Each of Santa Ana Unified School District's staff members, parent, and community partners have developed and maintained high expectations to ensure every student's intellectual, creative, physical, emotional, and social development needs are met. The district's commitment to excellence is achieved through a team of professionals dedicated to delivering a challenging, high-quality educational program. Consistent success in meeting student performance goals is directly attributed to the district's energetic teaching staff and strong parent and community support.

School Facility Conditions and Planned Improvements (Most Recent Year)

School custodial staff and the district's maintenance department work together to ensure classrooms and campus grounds are well-maintained and kept safe and functioning for students, staff, and visitors. Maintenance and Operations (M&O) employs an electronic work order system enabling school staff to communicate unscheduled maintenance needs, urgent repairs, or special projects. Most of the school's repairs and maintenance projects are performed by the district's highly qualified, professional trade specialists. Emergency situations are immediately resolved either by the school custodian or district maintenance staff, based upon the nature of the situation. Day and evening custodians work closely as a team and with the principal for routine maintenance, daily custodial duties, and special events preparations. The principal and day custodian communicate daily to discuss campus cleaning needs and safety concerns. Every morning before school begins, the custodian and principal inspect facilities for safety hazards, graffiti, and other conditions that require removal prior to students and staff entering school grounds. School safety and cleanliness are the custodians' highest priority and strongly emphasized as a component of their daily routines. Custodians are trained by M&O's administrators on proper cleaning procedures, use of chemicals, and use of equipment. The day custodians are responsible for following an established set of cleaning standards and prioritization procedures for general campus maintenance. The day custodian checks restrooms twice a day as a proactive measure in keeping facilities well stocked, safe, and sanitary. The evening custodians are responsible for thorough cleaning of classrooms, office areas, and restrooms. Groundskeepers are dispatched by the district office to perform general maintenance of landscaping, gardening, sports fields, and irrigation systems.

Edison provides Parent Education Opportunities that consist of weekly classes focused on Early Literacy and nutrition classes. ESL classes for parents are on campus four days a week for interested families and community. Monthly parent workshops are provided throughout the school year focused on literacy and academic engagement of students. All parents are welcome to volunteer at school to support their children and teachers throughout the school year.

The Edison staff and parents work together with the Orange County District Attorney's Office, the Santa Ana Police Department and the SAUSD School Police Department to bring our 5th grade students a Gang Reduction Intervention Program (GRIP). Volunteers from these departments meet regularly with staff, parents and 5th grade students to educate all on how to stay safe in their community. Parents are taught how to identify if their child is getting involved in the wrong groups and how to monitor students for safe use of the internet. Students are taught how to deal with bullying and gang recruitment. Students are motivated by the team to stay in school and focus on their goals. Our GRIP team also created a group of parents called Greeters. These parents station themselves on the streets approaching the school to welcome students and wish them a great day. Greeters provide additional supports around our school neighborhood for our students' safety.

Each school also meets with Santa Ana Unified School Police annually to discuss egress/ingress, crime data and other factors related to Crime Prevention Through Environmental Design (CPTED).

All curriculum and instructional improvement activities at Santa Ana Unified School District are aligned to the Common Core State Standards. Staff development concentrations are selected and identified based upon student assessment results, LCAP requirements, teacher input, state content standards, and professional development surveys.

All staff development activities in Santa Ana Unified School District are focused on increasing student learning and proficiency. During the 2020-2021 school year, Edison School is focused on the successful implementation of the ELD program. The program is embedded in all classrooms TK-5. Professional development on the program began in the 2019/2020 school year and is focused throughout the school year to include attending district workshops, school staff development, and program planning for teachers. Professional Development is also focused on reading instruction. All teachers have attended ELA training on the new reading curriculum and are participating in workshops and planning with colleagues throughout the school year. Due to the complexity of shifting instruction to an all virtual platform and hybrid model for the 2020/2012 school year, school staff, certificated and classified personnel, have participated in extensive professional development devoted to instructional techniques in an online format, distance learning equipment and programs, and developing synchronous and asynchronous lessons for students.

Santa Ana Unified School District offers supplemental training and support for new and ongoing program implementation. Training activities take place throughout the school year, after school, and during the summer and generally focus on curriculum, teaching strategies, and methodologies. District training opportunities focused on the following:

- ELD/ELA Instruction
- Math Instruction
- Differentiated Reading Instruction - Intervention Curriculum
- English Language Development for English Learners

At Edison teachers focused on text complexity, collaborative conversations and academic language. Teacher planning has focused on students having opportunities to solve problems creatively, to think critically, working collaboratively with peers, and engaging in inquiry based learning tasks and projects. Staff development at Edison occurs before the start of the school year as well as after school. Teachers are supported in the implementation of new strategies at Edison through in-class coaching, lesson studies, Instructional Rounds process, professional learnings, and Professional Learning Community meetings.

New teachers and teachers not yet fully credentialed are supported by peer coaching and extensive staff development. The TIPS Induction Program (Teacher Induction and Professional Support) is a state-approved program that offers additional support and assistance to newly credentialed teachers. All new teachers are assigned to a Support Provider (mentor teacher) and provided individualized support over a two-year period. More information about the TIPS Induction Program is available on www.sausdtips.org.

To support veteran teachers as well as new teachers to the district, Santa Ana Unified School District offers Peer Assistance and Review (PAR) which is easily defined as teachers helping teachers. Experienced and knowledgeable veteran teachers, referred to as Consulting Teachers, provide ongoing assistance to teachers who need to improve their instructional skills, classroom management strategies, subject knowledge, and/or related aspects of their teaching performance.

Staff members are encouraged to attend professional workshops and conferences. New teachers, experienced teachers, mentor/ teacher leaders, administrators, and support staff are encouraged to participate in workshops provided by SAUSD or sponsored by the Orange County Office of Education, as well as courses offered by community colleges and universities. Classified support staff receive additional job-related training from department supervisors and district representatives.
