School Description

Glenn L. Martin Elementary School (Martin Elementary) is located on the corner of West Wilshire Avenue and South Olive Street in central Santa Ana.

Martin Elementary's focus is two-fold: 1) to use instructional techniques and learning activities that will help students meet the Common Core State Standards and prepare them for college and career, and 2) to create a positive, nurturing school climate through positive behavior interventions and supports. This continues a long tradition at Martin Elementary of high academic expectations and a healthy, safe school environment for our students and staff. From analysis of student assessment data we know that we need to push students to read for comprehension and to use academic language in writing and speaking in order to help them be successful in school, and eventually, in college and career. Our school parents are a vital element in the education of Martin Elementary students and are welcome on campus as volunteers and life-long learners. Parenting classes are offered, with both day and evening schedules available. We host various classes and workshops on campus according to parents' interests, and including programs that invite parents to bring their preschool-aged children on campus to learn kinder-readiness skills that can be reinforced by parents at home. Parents are always welcome at Martin Elementary as partners in the education of the children in our community.

School Vision: Our vision is to prepare students for academic success and to become life long learners by guiding them in their construction of knowledge and development of problem solving skills.

School Mission: Martin Elementary is dedicated to creating a safe environment and a sense of community that inspires academic achievement, social-emotional health and a love of learning, in order to support the development of the whole child.

District Profile

Santa Ana Unified School District (SAUSD) is the eleventh largest district in the state, currently serving nearly 45,576 students in grades K-12, residing in the city of Santa Ana. As of 2019-20, SAUSD operates 36 elementary schools, 8 intermediate schools, 7 high schools, 4 educational options-secondary schools, and 1 dependent charter school. The student population is comprised of 81% enrolled in the Free or Reduced Price Meal program, 38% qualifying for English language learner support, and approximately 13% receiving special education services. Our district's schools have received California Distinguished Schools, National Blue Ribbon Schools, California Model School, Title I Academic Achieving Schools, and Governor's Higher Expectations awards in honor of their outstanding programs. In addition, 20 schools have received the Golden Bell Award since 1990.

Each of Santa Ana Unified School District's staff members, parent, and community partners have developed and maintained high expectations to ensure every student's intellectual, creative, physical, emotional, and social development needs are met. The district's commitment to excellence is achieved through a team of professionals dedicated to delivering a challenging, high-quality educational program. Consistent success in meeting student performance goals is directly attributed to the district's energetic teaching staff and strong parent and community support.

The Board of Trustees adopted Resolution No. 20/21-3370 which certifies as required by Education Code §60119 that for the 2020-2021 school year, the Santa Ana Unified School District has provided sufficient textbooks or instructional materials, or both, that are consistent with the content and cycles of the curriculum frameworks adopted by the State Board, to each pupil including those enrolled in a foreign language or health course, and that sufficient laboratory science equipment applicable to science laboratory courses offered in grades 9-12, inclusive, is available to pupils.

School Facility Conditions and Planned Improvements (Most Recent Year)

School custodial staff and the district's maintenance department work together to ensure classrooms and campus grounds are well-maintained and kept safe and functioning for students, staff, and visitors. Maintenance and Operations (M&O) employs an electronic work order system enabling school staff to communicate unscheduled maintenance needs, urgent repairs, or special projects. Most of the school's repairs and maintenance projects are performed by the district's highly qualified, professional trade specialists. Emergency situations are immediately resolved either by the school custodian or district maintenance staff, based upon the nature of the situation. Day and evening custodians work closely as a team and with the principal for routine maintenance, daily custodial duties, and special events preparations. The principal and day custodian communicate daily to discuss campus cleaning needs and safety concerns. Every morning before school begins, the custodian and principal inspect facilities for safety hazards, graffiti, and other conditions that require removal prior to students and staff entering school grounds. School safety and cleanliness are the custodians' highest priority and strongly emphasized as a component of their daily routines. Custodians are trained by M&O's administrators on proper cleaning procedures, use of chemicals, and use of equipment. The day custodians are responsible for following an established set of cleaning standards and prioritization procedures for general campus maintenance. The day custodian checks restrooms twice a day as a proactive measure in keeping facilities well stocked, safe, and sanitary. The evening custodians are responsible for thorough cleaning of classrooms, office areas, and restrooms. Groundskeepers are dispatched by the district office to perform general maintenance of landscaping, gardening, sports fields, and irrigation systems.

Parents are encouraged to be involved in Martin Elementary School's learning community by volunteering their time, attending school events, and sharing in the decision-making process. The LCAP process has inspired all in our community to offer suggestions and support to our school, as we work as a team for the benefit of our students. Martin Elementary School provides a wide range of opportunities for parents to interact with school staff while supporting their child's academic efforts, including: monthly parent meetings, Back to School Night, Open House, student performances, promotion activities, student recognition assemblies, and parent education trainings and/or workshops. School-to-home communication is provided in both English and Spanish via phone and text messages, Parent Square posts, the school web site, the Martin Elementary Facebook and Instagram pages, newsletters, flyers, the school marquee and general parent meetings. Through routine correspondence and special announcements, parents are kept informed on school news, student activities, schedules, policy changes, and curriculum updates. During the COVID-19 pandemic, parent meetings and workshops are all conducted virtually, for the safety of all in the school community. Also, some activities we would normally hold in person such as the jog-a-thon, family movie night, and family academic nights, are not held during the pandemic, in accordance to health department guidelines.

Parents are integral members of campus organizations that provide input on curricular programs, activities, and the design of the School's Plan, including School Site Council, English Language Advisory Council, and the Safety Committee. Parents in need of support and resources for their families are invited to inquire at Martin Elementary, and our administration and office staff works to link families to needed services. Our "Wellness Center" in room 15 is a place where parents can receive support from our FACE community liaison, who works with Martin families 2.5 days per week.
