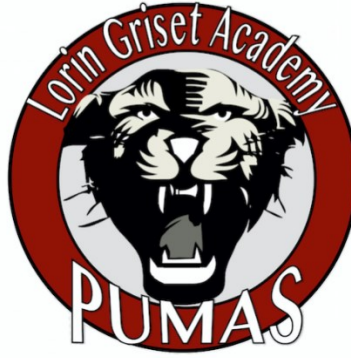

2021-22 School Overview

Lorin Griset Academy is located at 1915 West McFadden Avenue in the city of Santa Ana. Lorin Griset Academy provides both a learning environment that enhances our students' achievement through a challenging and standards-based curriculum and the support necessary to promote their social and emotional development. In 2017, 2019, and 2020, the school was recognized by the California PBIS Coalition with State recognition for its implementation of the core features of Positive Behavioral Interventions and Supports. In 2014, Lorin Griset Academy received a six-year term with a one-day revisit of accreditation from the Western Association of Schools and Colleges (WASC). The College Board approved the rigor of our standards-based course offerings to meet four-year university admission requirements. Each year, over 70% of Lorin Griset Academy's graduates enroll in institutions of higher learning.

Students from throughout the Santa Ana Unified School District (SAUSD) who are at least 16 years old and are credit deficient for their grade level enroll at Lorin Griset Academy to participate in the school's 9-week quarter-based credit recovery program to get back on track. The small-school setting allows students the opportunity to participate in a comprehensive yet individualized program. Several support programs provide academic and social safety nets, including for English Learners, Teen Parents, students who receive special education services, and foster youth. Enrollment in the school occurs through a referral process initiated by site administrators at comprehensive high schools for students who are deficient in credits. Pupil Support Services may refer less than 5% of students for inter-district transfers, involuntary placements, or readmission from expulsions. Students must complete 220 credits in required courses of study to be able to graduate and receive a high school diploma. These are the same graduation requirements as the other comprehensive high schools within SAUSD.

Vision Statement

Lorin Griset Academy re-engages students with renewed opportunities for hope and success by providing students the opportunity to recover academic credits with proficiency, as well as the social and emotional skills necessary to be productive members of their community and global society.

The Board of Trustees adopted Resolution No. 21/22-3421, which certifies as required by Education Code §60119 that for the 2021-2022 school year, the Santa Ana Unified School District has provided sufficient textbooks or instructional materials, or both, that are consistent with the content and cycles of the curriculum frameworks adopted by the State Board, to each pupil including those enrolled in a foreign language or health course, and that sufficient laboratory science equipment applicable to science laboratory courses offered in grades 9-12, inclusive, is available to pupils.

School Facility Conditions and Planned Improvements

School custodial staff and the district's maintenance department work together to ensure classrooms and campus grounds are well-maintained and kept safe and functioning for students, staff, and visitors. Maintenance and Operations (M&O) employs an electronic work order system enabling school staff to communicate unscheduled maintenance needs, urgent repairs, or special projects. Most of the school's repairs and maintenance projects are performed by the district's highly qualified, professional trade specialists. Emergency situations are immediately resolved either by the school custodian or district maintenance staff, based upon the nature of the situation. Day and evening custodians work closely as a team and with the principal for routine maintenance, daily custodial duties, and special events preparations. The principal and day custodian communicate daily to discuss campus cleaning needs and safety concerns. Every morning before school begins, the custodian, principal, and assistant principal inspect facilities for safety hazards, graffiti, and other conditions that require removal prior to students and staff entering school grounds. School safety and cleanliness are the custodians' highest priority and strongly emphasized as a component of their daily routines. Custodians are trained by M&O's administrators on proper cleaning procedures, use of chemicals, and use of equipment. The day custodians are responsible for following an established set of cleaning standards and prioritization procedures for general campus maintenance. The day custodian checks restrooms twice a day as a proactive measure in keeping facilities well stocked, safe, and sanitary. The evening custodians are responsible for thorough cleaning of classrooms, office areas, and restrooms. Groundskeepers are dispatched by the district office to perform general maintenance of landscaping, gardening, sports fields, and irrigation systems.

Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. There were no other assessment options available for the CAAs. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

2020-21 Career Technical Education Programs

The SAUSD Career Technical Education (CTE) program offers innovative and challenging courses with equitable access to prepare all students to be college and career ready through on-site, after-school, and virtual learning. Students take an integrated CTE course sequence called a CTE Pathway that focuses on an industry-specific program of study over a two to four-year period. SAUSD's CTE courses include a wide range of high-wage, high-skill, and high-demand career choices in the areas of science, technology, engineering, arts, and math (STEAM). CTE regional, county, and state competitions build industry skills and leadership through CTE student organizations. We continue to focus on adding pertinent industry recommended certifications and providing students the chance to work with businesses in our community through internships, field trips, and guest speaker opportunities.

CTE courses in Santa Ana combine real-world and work-based relevance with academic rigor and are aligned to meet both academic and California State CTE Standards. CTE courses also meet the rigorous "A-G" entrance requirements for the University of California (UC) and California State University (CSU) systems. In addition, many of our high school CTE courses offer either articulated or dual enrollment credit with local colleges that allow students to earn credit for both high school and college classes.

Professional Development

All curricular and instructional improvement activities at Lorin Griset Academy are aligned to the Common Core State Standards. Staff development concentrations are selected and identified based upon student assessment results, LCAP requirements, teacher input, professional development surveys, the Western Association of Schools and Colleges (WASC)-Action Plan, the School Plan for Student Achievement (SPSA), and the school wide area of focus. Professional development activities at Lorin Griset Academy are focused on meeting the school-wide student learning outcomes and implementing the School Plan for Student Achievement, thus increasing student learning, attendance, and the number of students who graduate high school and ready for their post-secondary learning experiences. Professional development at the site is implemented during the school's early-release Wednesdays where two Wednesdays a month are for teacher and committee collaboration, one Wednesday is for Faculty Meeting, and one Wednesday is for professional development. In addition, there are two full-days of teacher duty days that are set aside for data analysis, teacher collaboration, and site-leadership determined staff development. As a part of the school's improvement plan, teachers will also participate in up to three pull-out days for professional development.

During the 2020-2021 schoolyear professional development focused on distance learning and hybrid learning strategies. The focus was on the engagement of students in the virtual environment. Teachers worked on developing their proficiency in learning management systems and online tools to support students. The school continues to work on schoolwide training for Trauma-Informed Practices. During the current 2021-2022 schoolyear professional development is focused on the school's preparation for its WASC Full Self-Study in the Spring of 2022. The school is also focusing its professional development in the areas of Supporting our Long-term English Learners and grading and assessment practices.

The Santa Ana Unified School District offers supplemental training and support for new and ongoing program implementation. Training activities take place throughout the school year, after school, and during the summer and generally focus on curriculum, teaching strategies, and methodologies. New teachers and teachers not yet fully credentialed are supported by peer coaching and extensive staff development. The TIPS Induction Program (Teacher Induction and Professional Support) is a state-approved program that offers additional support and assistance to newly credentialed teachers. All new teachers are assigned to a Support Provider (mentor teacher) and provided individualized support over a two-year period. Staff members are encouraged to attend professional workshops and conferences. New teachers, experienced teachers, mentor/ teacher leaders, administrators, and support staff are encouraged to participate in workshops sponsored by the Orange County Department of Education and courses offered by community colleges and universities. Classified support staff may receive additional job-related training from vendors, department supervisors, and district representatives.
