2022-23 School Overview

Hector G. Godinez (Godinez Fundamental High School) is located at South Fairview Street and Centennial Road in the city of Santa Ana. The most recent graduation rate for Godinez Fundamental High School was 99.5% and 117 of those seniors received the Seal of Biliteracy, 90% of our seniors are enrolled in Colleges and Universities. 329 students completed college courses, 682 students are enrolled in 19 different AP courses. Over 485 students are involved in athletics, over 938 are involved in Visual and Performing Arts, 33 students are in Speech and Debate, 231 students are in AVID, and 430 are involved in student-driven clubs. In 2022, Godinez was rated #1 in the U.S. News and World Report Best High School in Santa Ana and in 2021 we were #8 in the Race to Submit Statewide Campaign with a 89% FAFSA & Dream Act submission rate. This was due to student accessibility limitations during COVID because of mandatory at home instruction. In 2017-2018 and 2018-2019 we were #2 and in 2019-2020 we were #1 in the Race to the Submit Statewide Campaign.

The mission of Godinez Fundamental High School is to provide a safe, supportive environment with clear, consistent expectations and high academic standards as well as preparing our students with 21st Century Skills. Technology is used school wide and at home to support the core curriculum. All students have a school issued electronic device, including hot spots for internet access, and access to numerous programs and databases that enrich and enhance core instruction. Teachers were issued a Z Book Firefly Laptop, an iPad and apple pencil, View Board, E-glass, speakers, and microphones. This gives teachers mobility during instruction and also allows teachers and students to use Google Classroom, Google Applications, Google Meet or zoom, and other instructional programs that are engaging for students and giving teachers additional resources to modify the curriculum to meet the individual needs of students. Godinez Fundamental High School is a community that prioritizes student engagement and academic achievement and character development. Each of us chooses to be a part of Godinez Fundamental High School; knowing this entails a commitment to academic excellence both during school hours and at home. As such, there are high expectations for all of us. The teachers are committed to preparation and presentation of strong, standards-based instructional programs, and to the assistance of students in meeting the goals of each course of study. The students are committed to high standards of attendance, behavior and academic rigor. The parents are committed to supporting their student's academic study by providing a place and time at home for students to complete their assignments and to meet with teachers as necessary or requested. Our out-of-school program, the Grizzly Lounge, operates daily before school (7:00 – 8:00 AM) and after school (2:47 – 6:00 PM). The program offers a robust academic support component that hosts over 150-175 students on a daily basis. In addition, the program also offers a variety of enrichment activities/clubs that center around Social Emotional Learning that include Polynesian/Hip-Hop dance, gardening, cooking,

Instructional materials for grades K-8 are selected from the state’s list of standards-based materials and adopted by the State Board of Education. Instructional materials for grades 9-12 are standards-based and approved by the district’s Board of Trustees. On September 27, 2022, the Santa Ana Unified School District’s Board of Trustees held a public hearing to certify the extent to which textbooks and instructional materials have been provided to students. The Board of Trustees adopted Resolution No. 22/23-3481, which certifies as required by Education Code §60119 that for the 2022-2023 school year, the Santa Ana Unified School District has provided sufficient textbooks or instructional materials, or both, that are consistent with the content and cycles of the curriculum frameworks adopted by the State Board, to each pupil including those enrolled in a foreign language or health course, and that sufficient laboratory science equipment applicable to science laboratory courses offered in grades 9-12, inclusive, is available to pupils.

School Facility Conditions and Planned Improvements

School custodial staff and the district's maintenance department work together to ensure classrooms and campus grounds are well-maintained and kept safe and functioning for students, staff, and visitors. Maintenance and Operations (M&O) employs an electronic work order system enabling school staff to communicate unscheduled maintenance needs, urgent repairs, or special projects. Most of the school's repairs and maintenance projects are performed by the district's highly qualified, professional trade specialists. Emergency situations are immediately resolved either by the school custodian or district maintenance staff, based upon the nature of the situation. Day and evening custodians work closely as a team and with administration for routine maintenance, daily custodial duties, and special events preparations. The day custodian and administration communicate daily to discuss campus cleaning needs and safety concerns. Every morning before school begins, the custodian and/or administrator inspect facilities for safety hazards, graffiti, and other conditions that require removal prior to students and staff entering school grounds. School safety and cleanliness are the custodians' highest priority and strongly emphasized as a component of their daily routines. Custodians are trained by M&O's administrators on proper cleaning procedures, use of chemicals, and use of equipment. The day custodians are responsible for following an established set of cleaning standards and prioritization procedures for general campus maintenance. The day custodian checks restrooms twice a day as a proactive measure in keeping facilities well stocked, safe, and sanitary. The evening custodians are responsible for thorough cleaning of classrooms, office areas, and restrooms. Groundskeepers are dispatched by the district office to perform general maintenance of landscaping, gardening, sports fields, and irrigation systems.

Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;

2021-22 Career Technical Education Programs

The SAUSD Career Technical Education (CTE) program offers innovative and challenging courses with equitable access to prepare all students for college and career readiness. Students participate in courses within the regular instructional day, during after-school expanded learning programs, and through virtual learning programs. CTE classes are vertically aligned from TK-12 starting with career awareness in TK-5th grades, career exploration in 6th-8th grades, while culminating with work-based learning experiences in high school.

Students complete an integrated CTE sequence of courses referred to as a career pathway that focuses on an industry-specific program of study over a two to four-year period. SAUSD's CTE courses include a wide range of high-wage, high-skill, and high-demand career choices in the areas of science, technology, engineering, arts, and math (STEAM). CTE regional, county, and state competitions help students build industry skills and leadership skills through participation in career technical student organizations (CTSO). SAUSD CTE continues to focus on expanding relevant industry recommended certifications and with providing students work-based learning opportunities at partner businesses within our community through internships, field trips, and guest speakers.

SAUSD CTE courses combine real-world relevance with academic rigor and are aligned to meet both academic and California State CTE Standards. CTE courses also meet "A-G" entrance requirements for the University of California (UC) and California State University (CSU) systems. In addition, many of our high school CTE courses offer either articulated or dual enrollment credit with local colleges that allow students to earn credit for both high school and college classes.

Professional Development

All curriculum and instructional improvement activities at Santa Ana Unified School District are aligned to the English learner instruction. Staff development concentrations are selected and identified based upon student assessment results, LCAP requirements, teacher input, state content standards, and professional development surveys.

Santa Ana Unified School District offers supplemental training and support for new and ongoing program implementation. Training activities take place throughout the school year, after school, and during the summer and generally focus on curriculum, teaching strategies, and methodologies. District training opportunities focused on the following (Trainings, collaboration, and coaching are being provided in person or through a virtual platform):

- Language Arts, Math, History, Science, Foreign Language, VAPA, or Physical Education
- AP Training (Advanced Placement)

* We have an instructional coach who works with teachers to co-plan, assist in the classroom, co-teach, help with educational software, and more.

Many Godinez teachers actively pursue professional development opportunities that will enrich the classroom experience for our students. We are fortunate to collaborate with district curriculum and instruction experts and the Orange County Department of Education to provide instructional support and ongoing outreach opportunities designed to enhance instructional methods. Currently, all Godinez teachers have been and/or will be trained on how to effectively use the View Board, E-Glass, Google Classroom, CANVAS, Zoom, Google Meets and technology based programs that will engage students and meet their educational needs. Teachers are also being trained in designated and integrated instructional strategies and activities. In addition, Math and Science teachers are working together for implementation of the new state standards. School-wide operations and processes are in place that promote a positive school climate, punctuality, and achievement.

New teachers are supported by peer coaching, site and district level professional development through the TIPS Induction Program (Teacher Induction and Professional Support) is a state-approved program that offers additional support and assistance to newly credentialed teachers. All new teachers are assigned to a Support Provider (mentor teacher) and provided individualized support over a two-year period. More information about the TIPS Induction Program is available on www.sausdtips.org.

To support veteran teachers, as well as new teachers to the district, Santa Ana Unified School District offers Peer Assistance and Review (PAR) which is easily defined as teachers helping teachers. Experienced and knowledgeable veteran teachers, referred to as Consulting Teachers, provide ongoing assistance to teachers who need to improve their instructional skills, classroom management strategies, subject knowledge, and/or related aspects of their teaching performance.

Staff members are encouraged to attend professional workshops and conferences. New teachers, experienced teachers, mentor/ teacher leaders, administrators, and support staff are encouraged to participate in workshops sponsored by the Orange County Office of Education and courses offered by community colleges and universities. Classified support staff may receive additional job-related training from vendors, department supervisors, and district representatives.
