#### 2022-23 School Overview

Middle College High School (MCHS) at Santa Ana College opened its doors in 1997. Middle College High School is a unique dual enrollment school of choice and collaborative venture between the Santa Ana Unified School District (SAUSD) and Santa Ana College (SAC). In addition to being part of the unified school and college districts, MCHS has, since its inception, been a member of the Middle College National Consortium (MCNC), a network of Middle College High Schools from throughout the country. These high schools are designed to introduce under-served students to the community college in an effort to motivate and encourage them to continue with their education after high school. Our students attend smaller size high school classes while also enrolling in college classes at Santa Ana College. The success of this program has resulted in hundreds of MCHS students from the last 20 graduating classes earning the Associates degree or 60 transferable college units at graduation from MCHS. Most students graduate from high school with 30 or more college units. The number of college credits a student earns depends on self-initiative and individual interest. Support programs abound at MCHS and SAC, e.g. professional tutoring, AVID classes to enhance higher level of study skills, and preparation for transitioning into college and university environments. In addition, MCHS has 2 full-time high school academic counselors and 1 part-time college academic counselor.

#### School Vision

At Middle College High School our vision is to empower our students into motivated, socially responsible citizens, who communicate effectively and are college and career ready.

#### School Mission

Middle College High School is an innovative dual enrollment school that partners with Santa Ana College. Our mission is to support our students on their college journey, ensuring that they graduate with at least 30 transferable college units, an AA Degree and/or a career ready certification. Students are encouraged to pursue their individual interests and engage in opportunities both inside and outside the classroom that will prepare them for the future.

#### **School Facility Conditions and Planned Improvements**

Santa Ana College's custodial staff and the district's maintenance department work together to ensure classrooms and campus grounds are well-maintained and kept safe and functioning for students, staff, and visitors. Maintenance and Operations (MandO) employs an electronic work order system enabling school staff to communicate unscheduled maintenance needs, urgent repairs, or special projects. Most of the school's repairs and maintenance projects are performed by either SAC's or the district's highly qualified, professional trade specialists. Emergency situations are immediately resolved either by the SAC's custodial or district maintenance staff, based upon the nature of the situation. Day and evening custodians work closely as a team and with the principal for routine maintenance, daily custodial duties, and special events preparations. The principal and SAC's facilities department communicate frequently to discuss campus cleaning needs and safety concerns. Every morning before school begins, the principal inspects facilities for safety hazards, graffiti, and other conditions that require removal prior to students and staff entering school grounds. School safety and cleanliness are the SAC's custodians' highest priority and strongly emphasized as a component of their daily routines. Custodians are trained by SAC's MandO's administrators on proper cleaning procedures, use of chemicals, and use of equipment. The day custodians are responsible for following an established set of cleaning standards and prioritization procedures for general campus maintenance. The day custodian checks restrooms twice a day as a proactive measure in keeping facilities well stocked, safe, and sanitary. The evening custodians are responsible for thorough cleaning of classrooms, office areas, and restrooms. Groundskeepers are dispatched by the SAC's MandO to perform general maintenance of landscaping, gardening, sports fields, and irrigation systems.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

#### 2021-22 Career Technical Education Programs

The SAUSD Career Technical Education (CTE) program offers innovative and challenging courses with equitable access to prepare all students for college and career readiness. Students participate in courses within the regular instructional day, during after-school expanded learning programs, and through virtual learning programs. CTE classes are vertically aligned from TK-12 starting with career awareness in TK-5th grades, career exploration in 6th-8th grades, while culminating with work-based learning experiences in high school.

Students complete an integrated CTE sequence of courses referred to as a career pathway that focuses on an industry-specific program of study over a two to four-year period. SAUSD's CTE courses include a wide range of high-wage, high-skill, and high-demand career choices in the areas of science, technology, engineering, arts, and math (STEAM). CTE regional, county, and state competitions help students build industry skills and leadership skills through participation in career technical student organizations (CTSO). SAUSD CTE continues to focus on expanding relevant industry recommended certifications and with providing students work-based learning opportunities at partner businesses within our community through internships, field trips, and guest speakers.

SAUSD CTE courses combine real-world relevance with academic rigor and are aligned to meet both academic and California State CTE Standards. CTE courses also meet "A-G" entrance requirements for the University of California (UC) and California State University (CSU) systems. In addition, many of our high school CTE courses offer either articulated or dual enrollment credit with local colleges that allow students to earn credit for both high school and college classes.
