## 2022-23 School Overview

REACH Academy is a Community Day School operated by the Santa Ana Unified School District. REACH Academy serves the District's students who have been expelled, referred by a School Attendance Review Board (SARB), referred by a Pupil Placement Committee (PPC) for behavior, attendance and/or performance issues, referred by Orange County Probation, and/or other youth at high risk. REACH Academy is WASC Accredited and offers "A-G" courses. REACH Academy operates a 360-minute instructional day, which is a student-centered approach that supports and embraces the diverse needs of the students by providing an alternative method of teaching, assessment and learning, rigorous and relevant teaching and curriculum, intervention, and prevention, extended learning opportunities, safe and healthy environment, and collaborative partners that are all Student-Centered. REACH Academy stands for Responsible Citizens, Effective Communicators, Active Learners, Critical Thinkers, and Healthy Individuals, which is truly what we want the students to become. REACH Academy has evolved over the past few years to become a Positive and Restorative Culture that offers a small school environment, low student to teacher ratios, more one-on-one student attention, powerful student and staff relationships, and a strong focus on Higher Order Thinking, Blended Learning, and Success Skills, which has created an environment where all students can strive to succeed. REACH Academy also offers a fully separate credit recovery program in the evening to support more students in their educational journey. The Credit Recovery PM Program at REACH Academy is a program to give students a chance at an alternative avenue to succeed in High School. This is an extension of REACH Academy and therefore will follow hand in hand with what we are continuing to do with our regular student population. The Credit Recovery program is assigned to any High School student that is enrolled in our school. All credit recovery classes will continue to be 4 periods and run from 3:30 pm - 8:00 pm with a quarter system schedule. This program is to help those students that are credit deficient that cannot be served at our current alternative educational sites. Per EdCode students that are 16 or older can go to a continuation school however, at REACH Academy we can accept students younger than 16 for credit recovery purposes.

Besides offering the traditional subjects such as English Language Arts, Mathematics, Social Studies, Sciences, Foreign Languages, Physical Education, and Electives, REACH Academy has created what is called the HEART class, which is an orientation class for all new students. Its purpose is to relieve the stresses these students and their families are experiencing, as well as to better prepare them for success. HEART stands for Hope, Engage, Achieve, Restore, and Transition. The HEART class was designed for the students to stay on average for 20 days, and each letter of HEART has a module created in Canvas that includes lessons about each letter of HEART. These lessons integrate technology, reading, writing, reflecting, sharing, restorative circles, cross-curriculum teaching, and career exploration. The HEART class is a collaborative effort with Project Kinship. Project Kinship is one of many community partners at REACH Academy. Project Kinship's Mission is to increase

community safety, promote hope, health, and well-being among the formerly incarcerated and their families, and help individuals successfully re-enter the community. Project Kinship is providing direct individual support with Case Management to students and families with support linked to community resources, one-to-one paraprofessional counseling, individual gang mediation, crisis-based gang intervention and de-escalation support, one-on-one substance abuse counseling services, and student home visits, providing group support with restorative practice circles, emotional literacy and anger management groups, after school restorative practice group, youth development activities, gang intervention groups, female intervention groups, and substance abuse groups. Other community partners on-site daily are Orange County Probation and Orange County Department of Education – Mental Health, as well as other community partners who help to provide extended learning opportunities. With all of this, we can meet the unique educational, social, physical, and emotional needs of the diverse students we serve and provide them with a second chance at success.

REACH Academy's Mission is to meet the unique educational, social, physical, and emotional needs of our diverse student population in a safe and nurturing environment; and to encourage students to develop an enthusiasm for lifelong learning and a desire to pursue college and career opportunities.

REACH Academy's Vision is a student-centered second chance at success. We do this by having caring staff that builds connections and relationships with students while providing alternative methods of teaching, assessment, and learning. The school offers a rigorous and relevant curriculum, strategies of prevention and intervention for at-risk behavior, and extended learning opportunities, all in a safe and healthy environment. With this approach, in collaboration with our community partners, we are able to meet the unique educational, social, physical, and emotional needs of the diverse students we serve.

### School Facility Conditions and Planned Improvements

School custodial staff and the district’s maintenance department work together to ensure classrooms and campus grounds are well-maintained and kept safe and functioning for students, staff, and visitors. Maintenance and Operations (M&O) employs an electronic work order system enabling school staff to communicate unscheduled maintenance needs, urgent repairs, or special projects. Most of the school’s repairs and maintenance projects are performed by the district’s highly qualified, professional trade specialists. Emergency situations are immediately resolved either by the school custodian or district maintenance staff, based upon the nature of the situation. Day and evening custodians work closely as a team and with the principal for routine maintenance, daily custodial duties, and special events preparations. The principal and day custodian communicate daily to discuss campus cleaning needs and safety concerns. Every morning before school begins, the custodian, principal, and assistant principal inspect facilities for safety hazards, graffiti, and other conditions that require removal prior to students and staff entering school grounds. School safety and cleanliness are the custodians’ highest priority and strongly emphasized as a component of their daily routines. Custodians are trained by M&O’s administrators on proper cleaning procedures, use of chemicals, and use of equipment. The day custodians are responsible for following an established set of cleaning standards and prioritization procedures for general campus maintenance. The day custodian checks restrooms twice a day as a proactive measure in keeping facilities well stocked, safe, and sanitary. The evening custodians are responsible for thorough cleaning of classrooms, office areas, and restrooms. Groundskeepers are dispatched by the district office to perform general maintenance of landscaping, gardening, sports fields, and irrigation systems.

#### SARC Reporting in the 2020-2021 School Year Only

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

#### Options

Note that the CAAs could only be administered in-person following health and safety requirements. - Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

The 2020-21 data cells have N/A values because these data are not comparable to other year data due to the COVID-19 pandemic during the 2020-21 school year. Therefore, the 2020-21 data between school years for the school, district, state are not an accurate comparison. As such, it is inappropriate to compare results of the 2020-21 school year to other school years.

## 2021-22 Career Technical Education Programs

The SAUSD Career Technical Education (CTE) program offers innovative and challenging courses with equitable access to prepare all students for college and career readiness. Students participate in courses within the regular instructional day, during after-school expanded learning programs, and through virtual learning programs. CTE classes are vertically aligned from TK-12 starting with career awareness in TK-5th grades, career exploration in 6th-8th grades, while culminating with work-based learning experiences in high school.

Students complete an integrated CTE sequence of courses referred to as a career pathway that focuses on an industry-specific program of study over a two to four-year period. SAUSD's CTE courses include a wide range of high-wage, high-skill, and high-demand career choices in the areas of science, technology, engineering, arts, and math (STEAM). CTE regional, county, and state competitions help students build industry skills and leadership skills through participation in career technical student organizations (CTSO). SAUSD CTE continues to focus on expanding relevant industry recommended certifications and with providing students work-based learning opportunities at partner businesses within our community through internships, field trips, and guest speakers.

SAUSD CTE courses combine real-world relevance with academic rigor and are aligned to meet both academic and California State CTE Standards. CTE courses also meet "A-G" entrance requirements for the University of California (UC) and California State University (CSU) systems. In addition, many of our high school CTE courses offer either articulated or dual enrollment credit with local colleges that allow students to earn credit for both high school and college classes.

## Professional Development

As a Community Day School, the legislation outlining the procedures for REACH Academy School states that there must be a 6 hour teaching day every day school is in session. This does not allow for modified days or staff development days. Therefore, the teachers at REACH Academy School participate in staff development before school, after school, and during school hours. The subjects covered during the staff development focus on four main areas: 1) Maintaining Positive School Culture; 2) Meeting the social/ emotional needs of our students; 3) Providing our students with rich, accessible academic opportunities; and 4) Skills for necessary for Academic Success so that every student leaving REACH is college and/or career ready. Sub-topics include Trauma-Informed, Therapeutic Web of Success, Restorative Practices, Restorative Practices with Circles, Positive Behavioral Interventions and Supports (PBIS), Zones of Regulations. Additional professional development topics, supported by our Instructional Coach, focus on blended and HyFlex learning with an emphasis on Canvas, Google tools, teacher web page creation.
