

Students that live outside the district are also able to attend once the lottery or waitlist of students that reside in the district has been exhausted. The Board of Trustees adopted Resolution No. 23/24-3534, which certifies as required by Education Code §60119 that for the 2023-2024 school year, the Santa Ana Unified School District has provided sufficient textbooks or instructional materials, or both, that are consistent with the content and cycles of the curriculum frameworks adopted by the State Board, to each pupil including those enrolled in a foreign language or health course, and that sufficient laboratory science equipment applicable to science laboratory courses offered in grades 9-12, inclusive, is available to pupils.

School Facility Conditions and Planned Improvements

School custodial staff and the district's maintenance department work together to ensure classrooms and campus grounds are well-maintained and kept safe and functioning for students, staff, and visitors. Maintenance and Operations (M&O) employs an electronic work order system enabling school staff to communicate unscheduled maintenance needs, urgent repairs, or special projects. Most of the school's repairs and maintenance projects are performed by the district's highly qualified, professional trade specialists. Emergency situations are immediately resolved either by the school custodian or district maintenance staff, based upon the nature of the situation. Day and evening custodians work closely as a team and with the principal for routine maintenance, daily custodial duties, and special events preparations. The principal and day custodian communicate daily to discuss campus cleaning needs and safety concerns. Every morning before school begins, the custodian, principal, and assistant principal inspect facilities for safety hazards, graffiti, and other conditions that require removal prior to students and staff entering school grounds. School safety and cleanliness are the custodians' highest priority and strongly emphasized as a component of their daily routines. Custodians are trained by M&O's administrators on proper cleaning procedures, use of chemicals, and use of equipment. The day custodians are responsible for following an established set of cleaning standards and prioritization procedures for general campus maintenance. The day custodian checks restrooms twice a day as a proactive measure in keeping facilities well stocked, safe, and sanitary. The evening custodians are responsible for thorough cleaning of classrooms, office areas, and restrooms. Groundskeepers are dispatched by the district office to perform general maintenance of landscaping, gardening, sports fields, and irrigation systems.

Professional Development

All curriculum and instructional improvement activities at Santa Ana Unified School District are aligned to the Common Core State Standards and strategies to help engage students in their learning. Staff development concentrations are selected and identified based on student assessment results, LCAP requirements, teacher input, state content standards, and professional development surveys.

In the Santa Ana Unified School District, our unwavering commitment is directed towards enhancing student learning and proficiency through comprehensive staff development initiatives. As we embarked on the 2023-2024 academic year, we prioritized two dedicated days for staff development preceding the commencement of the school term. The central theme of these sessions was the thorough training of our entire staff in the implementation of "Capturing Kids Hearts," a transformative methodology aimed at fostering self-managing classrooms. This implementation is an ongoing process, with scheduled walk-throughs in November 2023 to assess progress and determine subsequent steps. As December unfolds, we will diligently analyze data to pinpoint areas requiring refinement in our implementation, providing continued training for our teachers and Engage360 staff who may have missed the initial sessions.

Additionally, December 2023 will witness a one-day training session designed to bolster capacity among process champions. Beyond our focus on "Capturing Kids Hearts," our educators have also undergone rigorous training on the newly adopted History Social Science curriculum for the 2023-2024 school year. Commencing with a comprehensive overview in September 2023, we are committed to ongoing grade-level-specific sessions to offer further support and delve deeper into the intricacies of the novel curriculum. Furthermore, our primary staff members have received specialized training in the use of cutting-edge tools to reinforce phonemic awareness and phonics instruction within our TK-2 English language arts program. To ensure the safety of our school community, we will continue providing regular safety training updates throughout the academic year.
