# 2010-11 Budget Update

Business Services Associate Superintendent Michael Bishop gave the latest in a series of ongoing budget updates to the Board, revisiting items discussed in previous Board meetings. He summarized ongoing

budget reduction scenarios and discussed how other school districts are coping with budget reductions. Bishop also reviewed the Board priorities over the next five fiscal years and deepened his look at the effect of various levels of reductions on SAUSD.

It is still unclear how the State legislature will vote regarding placing a tax extension on the June ballot, which if passed, could help lessen the impact on cuts to education.



Regardless of the tax extension outcome, the Business Services team is taking steps to operate in the best interests of the school district. Therefore, the team and the Board will address what it will take to remain fiscally solvent in a special study session on Tuesday, March 1 at 5:30 p.m. Members of the public are welcome to attend the meeting.
