### **BACKGROUND INFORMATION:**

The purpose of this agenda item is to seek Board adoption of Resolution No. 10/11-2852 assuring that each student in SAUSD has sufficient **core** textbooks and/or instructional materials, including English Language Learners, within the first eight weeks of the school year.

The Williams Legislation, effective January 1, 2005, altered the previous requirements for district compliance and certification of adequate instructional materials. Board Education Code Sections 60119 and 60422(b) requires the governing board of any local agency receiving instructional material funds from any State source to hold a public hearing annually to determine whether sufficient **student core** instructional materials or textbooks are available for each student within the first eight weeks of schools. The call for Public Hearing took place at the September 28, 2010, Board of Education meeting.

### **RATIONALE:**

To comply with the Williams Legislation, Resolution No. 10/11-2852 is being submitted, wherein the Superintendent has determined and certifies that each student in the District has, in the 2010-11 school year, sufficient **student core** textbooks or instructional materials or both, in each of the following subjects, consistent with the content and cycles of the curriculum framework adopted by the State Board: reading/language arts, mathematics, science, and history/social science, elective courses in foreign language or health, and visual and performing arts. The Superintendent has also determined the availability of laboratory science equipment as applicable to science laboratory courses offered in the grades 9-12, inclusive.

The District's Technology Plan established E-Rate as a proven strategy that will help implement robust, cost-effective, future-ready infrastructure to support a broad educational technology vision. The integration of video, data, telecommunications, Internet, wired and wireless capabilities with teaching and learning have changed the requirements of the educational infrastructures. These converged networks allow students to use computers and other devices to access rich media over the Web or interact with other students and teachers in separate locations without ever having to leave the classroom. These converging technologies broaden learning opportunities and extend access to learning as well as reduce district operating expenses by integrating voice and data networks, such as voice over Internet Protocol (VoIP).

The Federal Communications Commission (FCC) has made available funds for voice and data internal connections that include structured cabling to meet the current need and provide for future growth of the network. The installation of network equipment and cabling at 21 sites scheduled for construction over the next three years utilizing E-Rate funds allows the District to leverage funds provided under Measure G for additional projects. The bid will meet E-Rate requirements for funding and may also be used for non-E-Rate cabling and equipment as District needs arise.

### **BACKGROUND INFORMATION:**

The purpose of this agenda item is to seek Board authorization for the purchase and installation of synthetic turf at Century and Santa Ana High Schools athletic fields utilizing a California Multiple Award Schedule (CMAS) contract number 4-06-78-0031A awarded to Fieldturf USA, Inc.

### **RATIONALE:**

At the July 29, 2010, meeting, the Board approved Century and Santa Ana High Schools Overcrowding Relief Grant Projects. ### **BACKGROUND INFORMATION:**

The purpose of this agenda is to seek Board approval of the new job description: Community and Family Outreach Liaison. This position will report to the principal at each of the six (6) transformational schools - Century, Saddleback, Santa Ana, and Valley High Schools, and Sierra and Willard Intermediate Schools. The creation of this position is required as one of the grant components of the \$35 million School Improvement Grant (SIG).

### **RATIONALE:**

This position is essential in providing support and outreach to the parents and community at the six (6) transformational schools – Century, Saddleback, Santa Ana, and Valley High Schools, and Sierra and Willard Intermediate Schools. The Community and Family Outreach Liaison will work with students and families to assist in dealing with issues that affect a student's academic performance that are not necessarily related to issues at school. The position will link students, parents, and school staff with community and public resources to provide greater services to the students and their families. SAUSD met with CSEA regarding this job description on September 28, 2010 and October 4, 2010. The new job description is attached.

Funding guidelines for the SIG grant designates the following positions at all six (6) transformational schools:

- Outreach Consultant Certificated
- Focus Coordinator Certificated
- TOSA: Math/ELA Certificated
- Community and Family Outreach Liaison Classified (multi-funded)
