Santa Ana Unified School District Non-Discrimination Statement:

# Saddleback High School IB Diploma Program Complaints and Student Appeals Procedures

1. A teacher will provide any student or their parent/guardian the opportunity to discuss a decision or situation that the student considers unjust or unfair.

2. If the incident remains unresolved, the student, their parent/guardian or the teacher may bring the matter to the IB Diploma Program Coordinator's attention for consideration and action.

a) The matter may be brought to the attention of the IB Coordinator through use of the "<u>Saddleback High School IB Program Complaints & Requests for Appeals</u>" Google Form (also found on Saddleback's IB Diploma Program's website).

3. If the incident remains unresolved, the student, their parent/guardian or the teacher may bring the matter to the principal/Head of School's attention for consideration and action.

a. The matter may be brought to the attention of the Principal through use of the "Saddleback High School IB Program Complaints & Requests for Appeals" Google Form (also found on Saddleback's IB Diploma Program's website).

4. If the matter is still unresolved, the complaining party may bring the matter to the Santa Ana Unified School District's compliance officer for consideration: **Compliance.Officer@sausd.us** 

5. If the matter is still unresolved, the complaining party may present it to the SAUSD Board of Education for review.
