RESOLUTION NO. 21/22 – 3416 RESOLUTION INITIATING PROCESS OF ESTABLISHING TRUSTEE AREAS AND ELECTIONS BY-TRUSTEE AREAS

WHEREAS, the Santa Ana Unified School District ("District") is governed by a five member Board of Trustees ("Board"); and

WHEREAS, the District currently uses an at-large system of electing the members of the Board; and

WHEREAS, the Board is aware that under state law an at-large method of election may be deemed to impair the ability of some voters to elect candidates of their choice or to influence the outcome of elections and, therefore, may be subject to challenge under the California Voting Rights Act of 2001, California Elections Code §§ 14025, et seq. ("CVRA"); and

WHEREAS, by-trustee area elections help promote a more democratic form of government by, among other things, helping to emphasize neighborhood representation and making it easier for local candidates to fund and successfully mount campaigns; and

WHEREAS, many school districts and other local agencies in Orange County have recently changed, or are in the process of changing, their elections in light of the CVRA; and

WHEREAS, the Board, based on its awareness of the foregoing, has had an ongoing interest in the issue, and has studied the issue, with the assistance and advice of legal counsel, and has decided to initiate the process of establishing trustee areas and changing the method of electing members of the Board, to ensure compliance with the CVRA or, at minimum, avoid the potential for costly litigation under the CVRA; and

WHEREAS, transitioning to a by-trustee area election method is and should be a time-intensive process, because the process does and should allow for extensive public input as required by Elections Code section 10010, includes the involvement of the Orange County Committee on School District Organization, and may involve seeking and obtaining a waiver of the requirement for an election from the State Board of Education; and

WHEREAS, the Board intends to initiate a very deliberate, careful, and public process for establishing trustee areas, and for changing the method of electing members of the Board, to take effect commencing with the November 2022 election.

NOW, THEREFORE, the Board hereby resolves, determines, and finds the following:

- **Section 1.** The foregoing recitals are true and correct.
- Section 2. The Resolution indicates the Board's intention to transition from at-large to bytrustee area elections under Elections Code section 10010(f)(1).
- Section 3. The Board directs the Superintendent or his designee to immediately initiate the legal and regulatory process to establish trustee areas within the District, as provided in
